1. Submission of BIDs/Tender Documents: Tenders should be submitted online in the website <https://etender.sbi/>. The Tender documents with acceptance of all terms and conditions strictly as described in this tender document will be submitted online through M/s e-Procurement Technologies Ltd., Ahmadabad, the out sourcing agency approved by the Bank for e-tendering on the website <https://etender.sbi/>
2. Contractors should submit/sent EMD physically on or before 3.00p.m on last date at the office of the Vice President, SBI Infra Management Solutions Pvt. Ltd., Amaravati Circle Office, 2nd Floor, SBI Amaravati LHO Building, Gunfoundry, Abids, Hyderabad. The tender will be rejected if the tenderer fails to submit soft copy of complete tender documents, EMD and application fee.
3. The acceptance of a tender will rest with the Competent Authority, who does not bind himself to accept the lowest tender and reserves to himself the authority to reject any or all of the tenders received, without assigning any reasons. 4. The firms should quote only one model in the tender and should not give any option of models of chairs. Any tender which has quotes more than one option will be summarily rejected.
5. Upholstery colour is Black.
6. The entire lot of chairs is to be supplied within the time mentioned in NIT failing which a penalty as mentioned will be imposed.
7. The rates quoted should be inclusive of all levies, transportation and taxes except GST.
8. GST as applicable will be reimbursed by bank as specified in NIT.
9. Tenders for works shall remain open for acceptance for a period of 90 days from the last date of tenders. If the tenderer withdraws his tender before the expiry of the said period or makes any modifications in terms and condition of the tender which are not acceptable to the Bank, then the Bank/SBIIMS without prejudice to any other right or remedy is at liberty to forfeit the earnest money.
