



## **SBI – Mastercard – Amazon Campaign T&Cs Document**

**Offer Terms effective May 23<sup>rd</sup>, 2022 ("Effective Date")**

### **1. Description of the Offer**

- (a) During the Offer Duration (as defined hereinafter), Mastercard shall offer any person who makes a purchases of Electronics product(s) (each a **"Product"** and collectively (**"Products"**) in Amazon Store on [www.amazon.in](http://www.amazon.in) or the mobile site or mobile application thereof (collectively, **"Amazon.in"**) using his/her Mastercard debit card issued by the State Bank of India (**"SBI"**) (such person hereinafter referred to a **"Cardholder"**), Instant bank discount on products purchased through mobile site or mobile application, subject to a minimum purchase of INR 5,000 per transaction;
  - (i) the Product is purchased using the Mastercard Debit Card issued by SBI, not being a corporate card. This offer is applicable for select SBI Debit Mastercard users only
  - (ii) Product is purchased in the month of May 2022 i.e., May 23<sup>rd</sup> to 29<sup>th</sup> 2022(**"Offer Duration"**)
- (b) The Electronics product category includes and is limited to audio, camera, personal computers and accessories, TVs and large appliances
- (c) Cardholders who fulfill the aforementioned criteria will be provided an instant discount of 10%, subject to a maximum of INR. 1000 once per Card.
- (d) The Offer shall be made available to the Cardholders in accordance with the terms and conditions set forth below to these Offer Terms. For the avoidance of doubt, the terms and conditions set forth below to these Offer Terms clarify the terms of the Offer as applicable between the Cardholder and Bank.

### **2. Offer Terms and Conditions**

- a) This **"Offer"** is provided to you by Mastercard and Amazon Pay (India) Private Limited (formerly known as Amazon Online Distribution Services Private Limited) (**"Amazon"**) and made available on the website [www.amazon.in](http://www.amazon.in) and the mobile site and mobile application thereof (collectively, **"Amazon.in"**).
- b) These Offer terms and conditions (**"Offer Terms"**) are in addition to the Amazon.in Conditions of Use & Sale and Privacy Notice to which you agree to by using Amazon.in. In the event of any conflict between the Conditions of Use & Sale and these Offer Terms, these Offer Terms will prevail, only for the purposes of this Offer.
- c) All residents of India holding a valid SBI Mastercard Debit card (Select cards) issued by the State Bank of India (**"SBI"**) (each a **"Card"**) are eligible to avail the Offer (each a **"Cardholder"**).
- d) This offer is applicable for select SBI Mastercard Debit Card users only.
- e) The Offer is valid for the dates May 23<sup>rd</sup> to 29<sup>th</sup> 2022. (**"Offer Duration"**), unless revoked or extended by Amazon (in its sole discretion), without any prior notice and without any liability.
- f) Under this Offer, any Cardholder who, during the Offer Duration, makes any purchase of select Electronics Products (audio, camera, personal computers & accessories, TVs, Large appliances) from Amazon.in and makes the payment using the SBI Mastercard Debit Card, will be entitled to receive an instant discount of 10% of the total purchase value for a successful purchase transaction made on Amazon.in, provided the purchase value for such transaction (inclusive of taxes) is equivalent to or exceeds INR 5,000 on a per transaction basis. Valid on only once per card during the offer period.
- g) The maximum discount provided under this Offer will not exceed INR 1000 per Card during the Offer Period.
- h) The Offer is NOT applicable on payment made by customers using the 'Cash/Card on Delivery' payment option.
- i) The purchase of Product by Cardholders on equated monthly instalments (EMI) will not be eligible for this Offer

- j) This Offer will not be applicable if the Cardholder or the seller or Amazon cancel the order and/or the Cardholder returns the Product and, in such a case, participation in the Offer will be deemed withdrawn. In such a scenario, only the net amount paid by the Cardholder will be refunded. In other words, the instant discount will not be refunded.
- k) In case there are multiple items in a purchase order, the item-wise savings/discount may vary. However, the overall savings/discount on the purchase order will be equivalent to maximum savings / discount the Cardholder is eligible for under this Offer.
- l) Amazon and/or the Mastercard reserve the right to disqualify the Cardholder from the benefits of the Offer if any fraudulent activity is identified as being carried out for the purpose of availing the benefits under the said Offer or otherwise by use of the Card.
- m) Amazon and/ or the Mastercard reserve the right, at any time, without prior notice and without assigning any reason whatsoever, to add/alter/modify/change or vary any or all of these Offer Terms or to replace, wholly or in part, this Offer by another offer, whether similar to this Offer or not, or to extend or withdraw it altogether.
- n) Delinquent and over-limit SBI's debit card members will not qualify for this Offer
- o) Cardholders are not bound in any way to participate in this Offer. Any participation is voluntary and the Offer is being made purely on a best effort basis.
- p) Nothing herein amounts to a commitment by the Mastercard or Amazon to conduct further, similar or other offers.
- q) The above Offer is by way of a special offer, and nothing contained herein will prejudice or affect the terms and conditions of the Card member agreement. The terms of the above schemes will be in addition to and not in derogation of the terms contained in the Card member agreement.
- r) This Offer is not valid on corporate or commercial Cards.
- s) This Offer is not available on: (i) purchase of products other than the Product(s), or (ii) purchase of Product using a card other than the Card(s).
- t) By participating in this Offer, every Cardholder expressly agrees that Mastercard, SBI and Amazon will not be liable or responsible for any loss or damage whatsoever that a Cardholder may suffer, directly or indirectly, in connection with the Offer including but not limited to that associated with his/ her use or delivery or misuse of the Product(s). Mastercard, SBI shall not be liable for delivery, service, suitability, availability or quality of the products offered under this offer.
- u) These Offer Terms are governed by the laws of India and the courts at New Delhi will have exclusive jurisdiction over any matters/ disputes arising out of or in relation to these Offer Terms.
- v) Any person availing this Offer will be deemed to have accepted these Offer Terms.
