I, Manisha Maheshwari, Partner of M/s. Bhandari & Associates, Company Secretaries, have been appointed as a Scrutinizer by the State Bank of India ("the Bank") for the purpose of scrutinizing the voting by electronic means i.e. remote e-voting and through e-voting system at the General Meeting ("GM") of the shareholders of the Bank, pursuant to Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") and Section 108 of the Companies Act, 2013 ("the Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended, on the resolutions contained in the Notice of the GM of the shareholders of the Bank dated March 27, 2025 read with its Corrigendum dated April 24, 2025, held on Friday, May 09, 2025 at 3.00 p.m. (IST) through Video Conferencing (VC)/Other Audio Visual Means (OAVM) in a fair and transparent manner.

The management of the Bank is responsible to ensure compliance with the provisions of the Act and the rules made thereunder including Ministry of Corporate Affairs ("MCA") General Circular No. 14/2020 dated April 8, 2020 and the subsequent circulars issued in this regard from time to time, the latest being circular No. 09/2024 dated September 19, 2024 (hereinafter collectively referred to as "MCA Circulars") and the Securities and Exchange Board of India ("SEBI") Circular No. SEBI/HO/CFD/CMD1/CIR/P/2020/79 dated May 12, 2020 and the subsequent circulars issued in this regard from time to time, the latest being Circular No. SEBI/HO/CFD/CFD-PoD-2/P/CIR/2024/133 dated October 3, 2024 (hereinafter collectively referred to as "SEBI Circulars") issued by SEBI and other provisions of the Listing Regulations and the SEBI Master Circular No. SEBI/HO/AFD/AFD-PoD-2/P/CIR/2024/70 for Foreign Portfolio Investors, Designated Depository participants and Eligible Foreign Investors dated May 30, 2024 relating to voting through electronic means by remote e-voting and e-voting at the GM by the shareholders on the resolution proposed in the Notice and corrigendum of the same of the GM of the Bank.

Further to the above, I submit my revised report as under:

- (i) Pursuant to the provisions of Regulation 44 of the Listing Regulations and Section 108 of the Act read with Rule 20 of the Companies (Management and Administration) Rules, 2014, MCA Circulars and SEBI Circulars, the Bank has availed the e-voting facility offered by NSDL for conducting remote e-voting prior to GM and e-voting at the GM by the Shareholders who attended the GM through VC / OAVM and who had not cast their vote through remote e-voting.
- (ii) In terms of MCA Circulars and SEBI Circulars, the Bank had sent the notice of GM and its corrigendum in electronic form only to its shareholders who have registered their email addresses with their respective Depository Participants.
- (iii) The GM Notice and corrigendum of the same was published in the Gazette of India on March 30, 2025 and April 28, 2025 respectively and public advertisement with respect to dispatch of notices and conducting of voting through electronic means and corrigendum of the same was published in an English and Hindi newspaper "Business Standard" and a vernacular newspaper "Aapla Mahanagar" of wide circulation in their respective editions dated April 04, 2025 and April 29, 2025 respectively.
- (iv) The shareholders of the Bank holding shares since the cut-off date i.e. Friday, February 07, 2025 as provided in Regulation 31 of the State Bank of India General Regulations, 1955 were entitled to vote on the resolutions as set out in the Notice of the GM and corrigendum of the same.
- (v) The voting period for remote e-voting commenced on Monday, May 05, 2025 at 10:00 a.m. and ended on Thursday, May 08, 2025 at 5:00 p.m. and thereafter, the voting portal was blocked forthwith.
- (vi) On Friday, May 09, 2025, after the conclusion of GM, the report on the e-voting carried at the GM and remote e-voting process were unblocked by me in the presence of two witnesses Ms. Palak Vora and Mr. Saurabh Somani.
- (vii) I have scrutinized and verified the votes cast through remote e-voting and e-voting at the GM based on the data generated from NSDL e-voting portal.

Note:

The Bank has issued a Corrigendum dated April 24, 2025, to amend certain resolutions proposed in the Notice of GM dated March 27, 2025, as follows:

i. Withdrawal of Item No. 14:

Resolution No. 14 and its Explanatory Statement has been withdrawn pursuant to cessation of Andhra Pradesh Grameena Vikas Bank (now renamed as 'Andhra Pradesh Grameena Bank'), related party of the Bank effective from May 1, 2025 in view of its amalgamation, in accordance with Regional Rural Banks ("RRB") amalgamation notification.

ii. Change of Name of Related Party in Item No. 18:

The name of Rajasthan Marudhara Gramin Bank has been changed to Rajasthan Gramin Bank wherever appears in Item No. 18 and its Explanatory Statement, in accordance with the RRB amalgamation notification.

As a consequence of the withdrawal of Item No. 14, the subsequent resolutions and explanatory statements originally numbered 15 to 18 have been renumbered as Item No. 14 to 17. Accordingly, the total number of business items transacted at the GM of the Bank were 17.
