Accordingly, all SME intensive branches/RBOs/AOs are advised to please go through the above contents and prepare themselves to receive Empanelment Application for Stock and Receivable Auditor as per notified guidelines and arrange to forward to CCO Deptt., LHO Jaipur with their recommendations with following precautions: -

- 1) Application should be received in the prescribed format only.
- 2) Proper scrutiny of the application should be done and verify the certificate(s) enclosed with the application and attest them properly.
- 3) While scrutinizing the applications, verification of enclosed certificates/documents should also be done.
- 4) Obtention of Proper KYC of the applicant/Candidate and verify them with the originals.
- 5) Ensure that all the papers are obtained as per notification.
- 6) Verify all the documents with office seal after proper checking and verification.
- 7) Arrange to forward the application with concerned AO's recommendations to CCO Deptt., Local Head Office, Jaipur.
