The full biodata & ID proof of the staff deployed at site like their full address, educational qualification, age pr oof, Aadhar card, photograph etc. shall be made available before commencement of work.
- **34.0** No alterations or additions are to be made by the Contractors to the tender document. Violation of th is instruction will attract rejection of the tender at the discretion of the Bank.
- **35.0** Tender shall be quoted on the prescribed format only. The tenders quoted in any other format shall be summarily rejected.
- **36.0** Quoted rates per unit being different from those prescribed in the tender shall render the bid disquali fied without any claim/explanation.
- **37.0** All the parts of this tender documents i.e., Tender Notice, General rules and Instructions to bidders, o ffer letter, General conditions of contract, Annexure etc. shall constitute part of the contract docume nt.
- **38.0** The contractor shall follow such Act, rules and regulations of the Local government bodies, State/Cen tral Government labour laws that are in force and that may be framed from time to time for completi on of work. SBI shall not be responsible for any infringement of the various statutes in force by the contractor.
- **39.0** The contractor must possess necessary valid Trade License (Housekeeping Service) from statutory a uthorities preferably in Bongaigaon or within the State of Assam and minimum three years old from t he cut-off date of the tender. The expenses in completing the formalities in executing the agreement including expenses towards stamp paper, Registration charges, etc., if any, shall be borne by the contractor.
- **40.0** STATUTORY DEDUCTION towards INCOME TAX, Work Contract Tax and any other statutory deduction s as per the law prevalent will be made as per Rules.
- 41.0 The contractor shall be responsible to ensure making payment of "Prevailing Minimum W ages" as notified by Regional Labour Commissioner (Central) to their labourers/ employe es directly in their Bank accounts and shall produce relevant documents to SBI for verific ation every month along with their monthly bills failing which bills may not be paid.
- 42.0 The contractor shall be bound to submit original challans and other documents with regard to payment confirmations of ESIC/EPF/any other statutory dues /compliances/pay slip a long with monthly bill to SBI, failing which bill will not be entertained.
- 43.0 PREQUALIFICATION BID DOCUMENTS & TECHNICAL BID:

The bidders are advised to upload various documents mentioned in Bid evaluation criteria (BEC) of th is tender document as technical bid on Gem portal.

Bidder not submitting any one or more documents mentioned in Bid evaluation criteria (BEC) and els ewhere in this document will be rejected in technical bid and price bid of such bidders will not be con sidered for evaluation.

- **44.0** No union formation is allowed.
- 45.0 The contractor shall deploy dedicated Supervisor(s)apart from the required manpower in the State Bank of India, Regional Business Office, Bongaigaon, Assam-783380, who shall b

e the first line of contact for SBI and who shall report to the designated officers of SBI for all the requirements. The Supervisor(s) shall personally supervise check and monitor the performance and working of the Cleaner, Plumber, Sweeper, Housekeepers, and other ho usekeeping personnel engaged by the Contractor on daily basis. The supervisor(s) shall be completely under the payroll of the Contractor whose salary/emoluments' payment will not be reimbursable by the bank. Biodata along with the Mobile numbers of supervisor(s) to be provided immediately on receiving the work order. One dedicated smart phone with sim is to be provided by the contractor to his /her supervisor at contractor expenses. Mon thly recharge for SIM card to be done by the contractor.

- **46.0** The estimated quantity for manpower and machines mentioned in this tender is minimum indicative. It shall, however, be sole responsibility of the contractor to ensure deployment of additional manpow er required, if any, for execution of work and services to the utmost satisfaction of client/employer/owner i.e. SBI without any extra charge but within the accepted tender amount only.
- **47.0** In case, any demand is raised by the Bank for providing additional manpower for any extra work /acti vity other than those pertaining to the scope of work of the captioned project, the contractor shall ma ke arrangements for the same and cost thereof shall be paid by the Bank on the basis of minimum w ages plus 10% handing charges.
- **48.0** All the chemicals, consumables required for the purpose of providing services will be provided by Ba nk.
- **49.0** The Contractor must have a well-established and functional office preferably in **Bongaigaon or in t he state of Assam** which is not less than 3 years old as on 31.01.2024. A copy of the valid trade license i ssued by the appropriate authority the State of Assam must be enclosed as a proof of establishment of office.
- **50.0**The Contractor must conduct a health camp for all the outsourced employees on yearly basis and mu st submit the logbook and attendance records to ensure 100 percent participation in the Health Camp of al I the employees under the Contractor engaged in the State Bank of India, RBO Bongaigaon and Branches under RBO Bongaigaon, Assam-783380.
- **51.0** The Contractor must not have any pending litigation or complain or disputes for non-compliance of a ny norms of any nature of the acts mentioned in Annexure-I of the Service Level Agreement.
- **52.0** The Contractor must ensure the supply of minimum 2 pair of Winter Clothes (Both Ladies and Gents), 2 pair of Uniforms (Both Ladies and Gents), 2 pair of Shoes (Both Ladies and Gents) on yearly basis along with the necessary protective gears (Both Ladies and Gents) as per the nature of work on time to time. The expenses of the same must be borne by the Contractor which is not reimbursable by the Bank.
- **53.0**The Contractor, even after the expiry of the period of contract will have to provide the service at the d iscretion of the Bank for a period of another 3 (Three) months or till the selection of the new contractor by the bank whichever is earlier on the same rate and terms and conditions. The Contractor may, after giving three months' notice to the Bank in advance to terminate the contract, if he so desires at any time during t he course of the currency of this agreement .Extension/Renewal for 1(One) year if required with similar ter ms on expiry of the current contract period, within sole discretion of the Bank, on the same terms and con ditions subject to satisfactory performance of the Contractor.

The extension/renewal of contract is to the entire discretion of the Bank and cannot be claimed as right of the Contractor.

- **54.0**The Contractor shall disburse salary to its deployed manpower as per Central Govt. minimum wages Act latest by 07th of every month, failing which penalty equivalent to one-day salary (Basic + DA) per dela yed day shall be credited by the contractor into the account of the respective employees whose salary has been delayed, apart from his regular remuneration which the contractor is payable to him. Proof of the sa me accompanied by the attendance sheet, salary slips, wage register, EPF statements & EPF challan & EPF TRRN payment confirmation receipt and ESI statements and ESI challan copy of the preceding month of the contract labours shall be submitted to the Bank along with the bills, sealed and signed by the Contractor or the respective signatories as per board resolution (if applicable) before 15<sup>th</sup> of the next month.
- **55.0** A copy of the ESIC cards of all the labours deployed by the contractor must be submitted to the bank within 2 months of the commencement of the contract.

### TERMS AND CONDITIONS OF THE CONTRACT

- **1.0 DEFINITIONS:** In the contract, the following expressions shall, unless the context otherwise requires , have the meaning hereby respectively assigned to them.
  - 'The Contract' means the documents forming the tender and acceptance thereof and the for mal agreement executed between Bank and the contractor, together with the documents referr ed to therein including these conditions and other instructions issued by the Employer from tim e to time and all these documents taken together, shall be deemed to form one contract and s hall be complementary to one another.
  - 'Employer' means State Bank of India, Regional Business Office, Bongaigaon, Pin-783380, Assam.
  - 'Competent Authority' means authority nominated to exercise power of approval, sanction a
    nd acceptance concerning administrative, financial and technical aspects of transactions done o
    n behalf of the Bank.
  - 'The Contractor or Contractors' means the firm, company or person engaged by the Bank to carry out the work. It shall also include their legal representative(s), successors or assigns.
  - 'Site' means State Bank of India, RBO Bongaigaon and Branches under RBO Bongaigaon where the works are to be carried out.
  - 'Contract value' means the value of the entire work as stipulated in the work order conveying
    acceptance of the tender subject to such additions thereto or deductions there from as may be
    made under the provision herein after contained.
  - 'The schedule of quantity' means the schedule of quantity as specified and forming part of this contract.
  - 'Works' or 'work' means the work(s) described in the "Scope of Work" and/or to be executed in accordance with the contract and includes labour, materials, apparatus, equipment of all kind is to be provided, the obligations of the contractor hereunder and work to be done by the contractor under the contract.
  - · 'Month' means calendar month.
  - · **'Week'** means seven consecutive days.
  - **'Day'** means a calendar day beginning and ending at 00 hrs and 24 hrs respectively. Where th e context so requires, words imparting the singular only also include the plural and vice versa; a nd, any reference to masculine gender shall include feminine gender and vice versa.
- **2.0 LANGUAGE:** The language in which the contract documents shall be drawn shall be English.
- **3.0 INSPECTION OF SITE:** The bidders are advised to inspect the sites and examine finishes (glass, alu minum composite panel, crystalline glass, Italian marble, granite, tiles, carpets, stainless steel cladding, veneers, laminates, building fixtures/ fittings, etc.) before quoting their rates. It is expected that the bidders will provide high quality services without damaging the existing finishes provided in the various areas of the premises.
- 4.0 CONTRACTOR TO INFORM HIMSELF FULLY: The service contractor shall be deemed to have care fully examined the work, site conditions including labour availability, various conditions, job requirem ents, schedules of equipment and shall be deemed to have visited the site of work, to have fully infor med himself regarding the local conditions and carry out their own investigations to arrive at the rate (s) to be quoted in the tender. In this regard, they will be given necessary information available with the Employer. If the contractor shall have any doubt as to meaning of any portion of the conditions, o r the scope of work or any other matter concerning the contract, he shall in good time, before submit ting his tender, ascertain the particulars thereof by contacting the concerned officials before tenderin g.

Once the tender is submitted, the matter will be decided according to contract conditions. For clarific ations / Doubts, the contractors may make full use of the pre-bid meeting which would be conducted at <a href="State Bank of India">State Bank of India</a>, Regional Business Office, <a href="Bongaigaon">Bongaigaon</a>, Assam-783380 as detailed in the Tender.

- **5.0 WORK TO BE CARRIED OUT:** The work to be carried out under the contract shall, except as otherw ise provided in these conditions, include all labour which may be required for carrying out the work s atisfactorily.
- **6.0 SUFFICIENCY OF TENDER:** The Contractor shall have deemed to have satisfied himself before ten dering as to the correctness and sufficiency of his tender for the works and of the rate(s) and price(s) quoted in the Schedule of Quantity, which rate(s) and price(s) shall, except as otherwise provided, co ver all his obligations under the Contract and all matters and things necessary for carrying out the wo rk.
- **7.0 AWARD OF CONTRACT:** The Bank will award the contract to the successful lowest bidder whose te nder has been determined to be substantially responsive and has been determined a successful eval uated tender, provided further that the bidder is determined to be qualified to perform the contract s atisfactorily.

The Bank reserves the right to increase or decrease the quantum of service to be provided and also r eserves the right to cancel or revise any or all the tenders or part of tenders without giving any reaso ns thereto with no cost to the Bank.

Bank reserve their rights to withdraw/cancel/delete any work in part or whole any time during the cur rency of contract by giving one month's notice in writing without assigning any reasons thereof and the contractor shall have no right to make any representation for the same.

- **8.0 Signing of contract Documents:** The successful bidder shall be bound to implement the contract by signing an agreement and conditions of contract with the respective establishment of SBI within 1 5 days from the receipt of intimation of acceptance of the tender by the Bank. However, the written a cceptance of the tenders by the Bank will constitute a binding agreement between the Bank and suc cessful bidder whether such formal agreement is subsequently entered into or not.
- **9.0 WORK ORDER:** Within the validity period of the tender, the Employer shall issue a work order by re gistered post / courier or otherwise handover personally to the contractor to enter into an agreement for carrying out the work as per the terms of the tender. The work order shall constitute a binding con tract between the Employer and the Contractor.
- **10.0 CONTRACT DOCUMENT:** On receipt of work order from the Employer, the successful bidder shall be bound to implement the contract and within 14 days thereof, he shall sign an agreement on a non-judicial stamp paper of appropriate value. The contractor shall be furnished, one certified copy of the contract documents as may be forming part of the tender papers. None of these documents shall be used for any purpose other than that of this contract.
- 11.0 EARNEST MONEY DEPOSIT (EMD): Rs 263629.47 (two Lakh sixty three Thousand six hundred twe nty nine and paise forty seven) only, to be deposited in the form of D.D. in favour of AGM, SBI RBO, Bo ngaigaon as proof of deposit the amount as part of the Technical Bid.
- **12.0 SECURITY DEPOSIT:** After finalization of Tender in future, the contractor will have to submit the Performance Bank Guarantee for 2% of contract amount calculated for a period of two years from a S cheduled Commercial Bank other than SBI or Security Deposit in the form of SBI Bank's draft in favour of Assistant General Manager RBO, Bongaigaon, Assam-783380 within a week of receipt of formal communication from the SBI about their successful bid. In case the Vendor fails to perform/commence the contract, the Bank shall invoke the Performance Bank Guarantee [PBG] or forfeit the Security Deposit to recover penalty/damages or any other amount due to the Bank /amount recoverable, the right to invoke the PBG for any noncompliance of the terms and conditions or any financial loss directly or indirectly by any act of commission or omission on the part of the Vendor and/or Vendor's workers, the Vendor shall compensate the Bank such loss fully.

In case the vendor fails to discharge any of his obligation under the agreement upto the level of performance desired, the Bank will have the right to get the job done (at the level of performance desired by The Bank) at its own expense and recover the actual expenses from the amounts payable to the v endor under the agreement.

13.0 Supervision of work: The contractor's authorized representative shall supervise the works. For an

y negligence of the service employed by the contractor or for any loss or damage caused or occasion ed by himself, his agents or workmen in respect of the property of SBI, the contractor shall be person ally responsible and shall make good the loss forthwith.

All activities of work done under this contract shall be entered in a register on a daily basis so that c omplete record of all the works performed is maintained and signed with date by both parties viz. per sons authorized for and on behalf of SBI / Bank and the contractor each day on completion of work.

**14.0 INSURANCE OF WORKS:** The contractor shall arrange and pay for policy under the Public Liability I nsurance Act, 1991 and keep insured all materials which are or have been declared to be hazardous under the notifications issued or that may be issued from time to time under the above said Act or an y Rule framed there under, and which are used during the course of the housekeeping services under these presents.

The contractor shall obtain adequate Insurance Policy in respect of his workmen engaged for the serv ice, towards meeting the Liability of Compensation arising out of death, injury/disablement at work et c. and shall regularly and punctually pay each and every premium as and when the same shall become due during the currency of these presents.

The contractor shall, from time to time, provide documentary evidence as regards payments of premi um for all insurance Policies for keeping them valid till the completion of the work.

Without prejudice to any of its obligations and responsibilities specified above, the Contractor shall, within 10 days from the date of work order, submit documentary evidence as required by the Employ er in support of having obtain requisite insurance cover.

No work shall be taken up by the Contractor at site unless the Insurance Policies as mentioned above are obtained.

Also, no payment shall be made to the Contractor on expiry of insurance policies unless renewed by them and renewed policy is submitted with the Bank. Nothing extra shall be payable on this account.

**15.0 ASSIGNMENT, SUBLETTING AND CONTRACTOR'S SUPERINTENDENCE:** The whole of work inclu ded in the contract shall be carried out by the contractor and he shall not directly entrust and engag e or indirectly transfer assign or underlet the contract or any part or share thereof or interest therein without the written consent of the Employer and no undertaking shall relieve the contractor from the responsibility of the contractor from active superintendence of the work.

In case of breach, the Bank shall be at liberty to serve notice and rescind the contract along with forf eiting of the security deposit and invoke the Bank guarantee/ performance guarantee if required.

16.0 PROTECTION OF WORKS AND PROPERTY: The contractor shall continuously protect the Employe r's properties from damage or loss arising in connection with contract. He shall make good any such damage, injury, loss resulting due to his fault or negligence except due to causes beyond his control. In case the contractor fails to make good the losses caused to the Bank due to his fault or due to negligence of his staff, Bank reserves the right to invoke the security deposit as stated above to cover su ch losses.

The contractor shall take all precautions for safety and protection of his employees on the works and shall comply with all applicable provisions of government and local bodies safety laws and building c odes to prevent accidents, or injuries to persons or property in or adjacent to his place of work. The c ontractor shall take insurance covers as specified elsewhere in the contract at his own cost. The polic y shall be taken in joint names of the Employer and the contractor.

In case of flooding of site on account of rain or any other cause and any consequent damage, whatso ever, no claim financially or otherwise shall be entertained not withstanding any other provisions els ewhere in the contract.

**17.0 WAGES TO BE PAID:** The Bank will pay the Contractor said contract amount, (hereinafter referred t o 'the Contract Sum') or such other sum as shall become payable hereunder at the times and in the P rice Bid and the said conditions.

The payment will be made as per actual manpower deployed for works and on satisfactory completion of the work and on submission of the bill along with all the documentary evidence regarding payment of salary to their employees.

All payments by the Bank under this contract will be made at State Bank of India, Regional Business Office, Bongaigaon, Assam-783380 in Indian Rupees and shall be within 2 to 3 weeks from the sub mission of bills including period of checking subject to bills being complete in all respects as mention ed in the tender and, in the format, to be mutually agreed.

All taxes prevailing during the currency of contract shall be payable by the Facility Management (FM) Service Contractor within the accepted tender amount only and the Bank will not entertain any claim whatsoever in this respect.

That the terms of this contract have been read by the FM Service Contractor and fully understood by him/ them. The FM Service Contractor shall not be entitled for the payments for the quantities beyon d the tendered quantities unless specifically ordered for, by specific instructions with prior approval fr om the Bank.

The following components should necessarily be present in the pay structure applicable to the House keeping service staff:

- · Basic Pay
- · D.A.
- · EPF
- ESIC
- Bonus

Please note that all the above components should be necessarily present in the pay structures to be adopted /paid to all the categories of staff viz. Facility manager, Manager, Supervisors, attendants (b oth male and female). The contractor may like to add any other component as they may desire to the above list to have better staff at their own cost and effect of same may considered while quoting the service charge by the bidder in the price bid format of this tender. However, Bank will only reimbur se the above listed component as minimum wage for the workers as applicable.

If the amount quoted as service charge by the bidder in the Price Bids is unreasonable/ u nrealistic or with Zero profit margin, based on the statutory payments or otherwise, the Bank reserves the right to reject such bids.

- **18.0 PROCUREMENT OF CLEANING AND OTHER MATERIALS:** All the cleaning materials and consuma bles as required for the entire scope of work shall be supplied by the Bank.
- **19.0 UNIFORM:** The contractor shall provide New Uniform (with Company's name badge and approved by bank) including Safety Shoes, Helmet, Safety Belt, Hand Gloves, head cap, appron etc. to all its employees deployed in the premises within the quoted rate(s) and no extra payment shall be made to contractor on this account.
- **20.0 PAYMENT OF BILLS BY THE BANK:** Neither any advance nor any loan from any Bank or financial institution shall be recommended on the basis of Work Order or Award of work.

The payment of monthly bills in respect of the captioned Contract shall be paid by respective branch es/offices of State Bank of India only after all documents as indicated below are submitted along with the bill:

- · PF challan, PF statements and TRRN payment confirmation receipt for the previous month.
- · A separate sheet mentioning the names of the staff deputed at SBI Site,
- · Wages/Salary amount credited in the Bank's account of individual,
- Amount of PF & ESI Deposited in their respective account. The statement should have the PF n umber of the staff and the agency shall fix its official seal and signature on the statement.
- A separate covering letter undertaking that the PF amounts have been credited rightly asper the e statement enclosed should also be submitted.
- · ESIC challan for the previous month along with separate sheet mentioning the names of the sta

ff deputed at SBI Site (name of site to be mentioned) and the amount credited against their account with the ESIC office.

- The statement should have the ESIC number of the staff and the agency shall fix its office seal
  and signature on the statement. A separate covering letter undertaking that the ESIC amounts
  have been credited rightly as per the statement enclosed should also be submitted. For staff w
  ho are out of the ESIC ambit, clear details of number of people covered under ESIC and Workme
  n compensation policy shall be indicated.
- The original wages register, signed by your employees deputed to SBI sites, in token of receipt of payment for the previous month, should be submitted for certification of SBI/Bank representative, as the principal Employer, every month.
- · Salary Slips of the respective month with detailed break-up, of all the labourers employed in bank premises by the Contractor.

Whenever under the contract any sum of money shall be recovered from, or payable by the contract or, the same shall be paid by the contractor on demand. The Bank may also deduct such amounts from any dues of the contractor, or from any sum which at any time there after becomes due to the contractor under his contract or under any other contract or from his security deposit, in respect of this work or in respect of any other works.

If State Bank of India engages workers to complete any part or whole of the work as per this contract for any period, due to failure of the contractor to engage adequate number of workers ,in that event, contractor has to reimburse to SBI, the extra cost involved on this account.

- **21.0 WORK ON SUNDAY AND HOLIDAYS:** The contractor has to arrange for engaging his workers on S unday and holidays, for thorough deep cleaning of the internal and external areas as required by the employer. No Extra payment on this account will be made by the Employer. However, there should b e one weekly holiday for each employee on rotation basis and reliever if any required to be arrange b y contractor at his own cost.
- **22.0 ADDITIONAL WORK:** Should any new areas of work transpire, which the Employer considers are no t envisaged, as being part of this tender, the prices for the new scope of work shall be mutually decid ed and agreed upon between the Employer and the contractor based on actual rate analysis on estab lished norms. In the event of non-agreement of the rates, the Employer reserves the right to get the s ame carried out through any other agency so appointed for.
- **23.0 COMPLIANCE WITH ALL STATUTORY REQUIREMENTS:** The Contractor shall comply with all stat utory requirements prescribed by the local as well as state / central government authorities from tim e to time and submit required proof of compliance to the Employer as and when required by the Employer. The contractor shall produce all the relevant statutory documents for inspection by the Employ er and the government authorities.

The contractor shall give all notices required under the said Act, Rules, Regulations and Bye laws etc. and pay all fees payable to such authority/authorities for carrying out the work towards the cost, if a ny, shall be deemed to have been included in his quoted rates, taking into account all liabilities for li censes, fees etc. and shall indemnify and protect the Employer and its Employees against such liabilities and/or claim arising out of violation of any such laws, ordinances, orders, decrees and shall defen d all actions arising from such claims or liabilities.

If the contractor performs any act which is against the law, rules and regulations, he shall meet all the costs and consequences arising there from and shall indemnify the Employer against any legal actions arising there from.

- **24.0 OTHER COMPLIANCES:** The Contractor should ensure compliance of the following for smooth exec ution of work:
  - Identity card should be issued by the contractors to the contract staff deputed on State Bank of India site.
  - · All contract staff deputed by the contractor at SBI site should have in possession Identity card i ssued by the contractors.
  - $\cdot$   $\;$  The Payment slips should be issued by the contractors to the staff deputed on SBI site.
  - · All Contract staff should bear specified uniform bearing badges of Company's name, Shoes and

Identity Card sand other safety accessories, viz Helmet, Safety belt, etc.

- **25.0 LOCAL LAWS, ACTS, and REGULATIONS:** The contractor shall strictly adhere to all prevailing lab our laws including of contract labour (Regulation and Abolition Act, 1970) and other safety regulation s. The contractors shall comply with the provision of all labour legislation including the latest require ments of all the laws, directions and guidelines that are applicable for carrying out the work, including without limitation, the following:
  - · Minimum Wages Act, 1948
  - · Payment of Wages Act 1936
  - · Workmen's Compensation Act 1923 (Amended), as applicable
  - · Contract Labour Regulation and Abolition Act 1970 and Central Rules 1971
  - Apprentice Act 1961
  - · Industrial Employment (Standing Order) Act 1946
  - · Personal Injuries (Compensation Insurance) Act 1963 and any other modifications
  - · Employees' Provident Fund and Miscellaneous Provisions Act 1952 and amendment thereof
  - Employees State Insurance Corporation Act
  - · Shop and Establishment Act, as applicable
  - Any other Acts Central or States, that may be applicable or bye law or enactment relating ther
    eto and rules framed there under from time to time.
  - · Factories Act.
  - · Employment of Children Act 1938,
  - · Employers Liability Act 1938,
  - · Industrial Disputes Act 1947

The contractor shall be liable to pay all such sum, or sums that may become payable as contribution, compensation, penalty, fine or otherwise, which the provision of the said acts, to or on behalf of any workmen employed by the contractor by an authority empowered under the relevant Act.

Any cost incurred by SBI / Bank in connection with any claim or proceedings under the said Acts or in respect of loss, injury or improper performance of this contract by the contractor or his workmen and any money which may become payable to State Bank of India as aforesaid shall be deemed to be de ducted by State Bank of India or may be recovered by the Bank from the contractor.

The Contractor shall keep the Employer saved harmless and indemnified against claims, if any, of the workmen and all costs and expenses as may be incurred by the Employer in connection with any claim that may be made by any workmen relating to work carried out by the contractor for this contract.

**26.0 CONTRACT PERIOD:** The work shall be awarded for a period **of Two year** from the date of comme ncement of the work subject. Extension/Renewal for 1(One) year if required with similar terms on exp iry of the current contract period, within sole discretion of the Bank, on the same terms and condition s subject to satisfactory performance of the Contractor.

The extension/renewal of contract is to the entire discretion of the Bank and cannot be claimed as right of the Contractor.

If the contractor fails to perform any of its duties under this agreement and if the Employer is dissatis fied with the services of the contractor during the contract period or extended period of service, the E mployer may terminate the services of the contractor, by issuing one month's notice in writing to win ding up.

**27.0 DISMISSAL OF WORKMEN:** The contractor shall on the request of the Employer immediately dismi ss from works any person employed thereon by him, who may in the opinion of the Employer be uns uitable or incompetent or who may misconduct himself. Such discharges shall not be the basis of any claim for compensation or damages against the Employer or any of their officer or employee. The co

ntractor shall take necessary steps as per law in such situations.

**28.0 TECHNICAL AUDIT / SCRUTINY:** The Employer shall have right to carry an audit / technical examin ation of the works and the bill of the contractor including all supporting vouchers, abstracts etc. by an y of the persons or organizations as appointed by the Employer.

If as a result of the examination or otherwise any sum is found to have been overpaid or over certifie d, it shall be lawful for the Employer to recover the sum from any payment due to the contractor for s uch work.

### 29.0 INSPECTION BY EMPLOYER:

- a) General: The Employer shall have the right to inspect at all times the performance of the WORKS. The cont ractor shall make all parts of the WORK accessible for these inspections.
- b) Rejection of work and Equipment: The Employer shall have the right to condemn any or all tools, instrume nts, materials /chemicals, equipment or work which does not confirm to the specifications.

The contractor shall be responsible for any breakage caused by its workers at the site. Break age of a ny light fixtures, furniture, tiles, mirror, glass, any other fittings/fixtures provided in the building by the persons employed by the contractor due to their negligence will have to be set right by the contractor at his cost within 3 days of such damages. In case of their failure to do so, the Bank shall be at liberty to get the same done from any other agency at the Contractor's cost, risk and consequences.

### **30.0 REPORTING AND RECORD KEEPING:**

- a) Management reporting and process reviews: The Employer shall approve the format for the monthly report to be submitted by the contractor along with every monthly bill.
- b) Operating Meetings: During the early stages of the agreement, it is expected that the frequent operation meetings will be required between the service contractor's manager and employer's representative/s to di scuss priorities to establish satisfactory reporting procedures. The contractor shall make the appropriate p ersonnel available for attending all these meetings.
- c) Performance Review Meeting: Performance review meetings shall be held quarterly to review the overall p erformance of the contractor. The Senior Management of the contractor and Employer shall attend these meetings.
- d) Quality Assurance: The contractor shall implement a quality system in accordance with ISO standards. The contractor shall develop, in conjunction with the Employer's representatives, the standards of service to be provided and how performance to be measured and monitored.
  - **31.0 FORCE MAJEURE:"** Force Majeure" shall mean any event beyond the control of Bank or of the Cont ractor, as the case may be, and which is unavoidable notwithstanding the reasonable care of the part y affected, and which could not have been prevented by exercise of reasonable skill and care and go od industry practices and shall include, without limitation, the following:
    - · War, hostilities, invasion, act of foreign enemy and civil war;
    - · Rebellion, revolution, insurrection, mutiny, conspiracy, riot, civil commotion and terrorist acts;
    - · Strike, sabotage, unlawful lockout, epidemics, guarantine and plague;
    - · Earthquake, fire, flood or cyclone, or other natural/ manmade disaster;

As soon as reasonably practicable but not more than 48 (forty-eight) hours following the date of commencement of any event of Force Majeure, an Affected Party shall notify the other Party of the event of Force Majeure setting out, inter alia, the following in reasonable detail:

- · The date of commencement of the event of Force Majeure;
- · The nature and extent of the event of Force Majeure;
- · The estimated Force Majeure Period,

Reasonable proof of the nature of such delay or failure and its anticipated effect upon the time for pe rformance and the nature of and the extent to which, performance of any of its obligations under the Contract is affected by the Force Majeure.

The measures which the Affected Party has taken or proposes to take to alleviate/mitigate the impact of the Force Majeure and to resume performance of such of its obligations affected thereby.

Any other relevant information concerning the Force Majeure and /or the rights and obligations of the Parties under the Contract.

**32.0 ACCIDENTS:** The contractor shall immediately on occurrence of any accident during carrying out th e work report such accident to the Employer. The contractor shall also report such accident immedia tely to the concerned authorities whenever such report is required to be lodged by law and take appr opriate actions thereof.

The contractor shall submit report of all accidents, fires and property damage, dangerous occurrence to the authorized Bank officials immediately after such occurrence, but in any case, not later than tw elve hours of the occurrence. Such reports shall be furnished in the manner prescribed by State Bank of India. In addition, the contractor to the authorized Bank, official shall also submit periodic reports on safety from time to time as prescribed.

**33.0 LABOUR:** The Contractor shall employ suitable labour to carry out the respective work to the satisfaction of the Bank.

The contractor shall furnish to the Bank at the intervals specified by Bank, a distribution of the numb er and description of labour employed in carrying out various works /activities.

The Contractor shall submit on every month to the Bank a statement showing in respect of the preceding month:

- · The number of labourers employed by them on the work.
- · Their working hours.
- · The wages paid to them.
- The accidents occurred, if any, during the said month showing the circumstances under which they happened and the extent of damage and injury caused by them And
- The number of female workers who have been allowed maternity benefits as provided in the maternity benefit Act, 1961 or Rules made there under and the amount paid to them.
- The contractor shall apply and obtain license under the Contract Labour (R&A) Act 1970and co
  mply with the relevant provision of this Act, in respect of the labour employed by him for execu
  ting this contract. The contractor shall furnish necessary returns to the authority through Bank.
- The minimum age of the labour employed shall not be below 18 years.
- The contractor should take independent code numbers under EPF Act 1952 and ESI Act1948 an
  d shall cover his workmen under the employee's provident fund schemes and Employees State
  Insurance Act 1948 and show proof of payment o f subscriptions /contributions to the concerne
  d authorities.
- Both in respect of ESI/EPF the contractor shall obtain necessary declaration forms from his emp loyees and obtain individual insurance and PF number and shall furnish to the Bank every mont h, necessary proofs for having made remittance of ESI and PF contributions in respect of all con tract labourers engaged by him.
- As regards Employees State Insurance Act, the contractor shall submit Photostat copies of the c
  hallans of remittance of the contributions (both the employee's contributions and his own contri
  bution there on) to the ESI corporation in respect of the employees engaged in State Bank of In
  dia by him for this work for the relevant period before any payment is released by State Bank o
  f India.
- As regards the Employees Provident Fund and Miscellaneous Provision Act 1952 and rules and r egulations and schemes framed there under, he shall be liable to pay employees compensation under the Act in respect of all labour employed by him for the execution of the contract. For this purpose, he shall indicate the code number obtained by him from the Regional Provident Fund Commissioner and produce the Photostat copy of the challan receipt of monthly remittance.
- · He shall also furnish such returns as are due under the Act to be sent to the appropriate authori ties through State Bank of India.

- The contractor is required to take Insurance for all the workers employed on the works towards payments for workmen compensation. The Insurance has to be taken within 15days of the awar d of work and has to be provided at the signing of the agreement.
- The contractor shall be fully responsible for the consequences arising out of default and Bank may treat it as breach of Contract and reserves the right to terminate the Contract.
- The contractor shall pay wages to his workmen at the rates as applicable under the Minimum W ages Act as per Central Government guidelines for unskilled and for semiskilled/equivalent cate gories.
- The contractor shall disburse the wages through credit to their accounts and account statemen t should be enclosed along with the monthly bill.
- The duration of duty is eight hours per day per person. To keep the efficiency and alertness the overtime will be kept to the barest minimum.
- The staff/workers employed by the contractor shall not find under the influence of alcohol or an y abusive substance at any point of time. Further, the mobilization of the workers engaged shall be such that they maintain the dignity of the office at all time and any incident of mobilization or indecency is noticed at the workplace, Bank shall have ther ight for asking replacement of such workers employed by the contractor.
- **34.0 TERMINATION:** Bank shall be at liberty to terminate the contract by issuing **one month's notice** t o the contractor without assigning any reason whatsoever. Bank shall not pay any claim/compensatio n by Contractor for such termination of Contract.

As regards unsatisfactory performance or non-compliance with any of the terms and conditions of the contract by the contractor or abandoning the work, the Bank /State Bank of India shall have the right to terminate the contract forthwith with one month's notice and rearrange the work through other ag encies at Contractor's risk, cost and consequences and under such circumstances, the security depos it paid by the contractor shall stand forfeited ,besides any other action deemed fit including depaneling the contractor or debarring them in future tendering process.

Without prejudice to any rights or remedies under this agreement if the contractor dies, the Bank aut horities shall have the right to terminate this agreement without any liability whatsoever as regards execution of the work for the balance contract period after the death of the contractor.

**35.0 SAFETY CODE - RESPONSIBILITIES OF THE CONTRACTOR IN RESPECT OF SAFETYOF MEN, EQUIPMENT, MATERIAL AND ENVIRONMENT:** Before commencing the work, contractor submits a 'SAFETY PLAN' to the authorized Bank official. The 'SAFETY PLAN' shall indicate in detail the measure that would be taken by the contractor to ensure safety of men, equipment, material and environment during execution of the work. The plan shall take care to satisfy all requirements specified hereunder . The contractor shall submit Safety Plan along with his offer. During negotiations before placing of w ork order and during execution of the contract Bank shall have right to review and suggest modificati on in the Safety Plan. Contractor shall abide by the Bank's decision in this respect.

The contractor shall take all necessary safety precautions and arrange for appropriate appliances as per direction of Bank or its authorized officials to prevent loss of human lives, Injuries to personnel engaged and damage to property and environment.

The contractor shall provide to its work force and ensure the use of the following personal protective equipment as found necessary and as directed by the authorized Bank officials: -

- · Safety Helmets conforming to IS-2925:1984
- Safety Belts conforming to IS-3521:1983
- Safety Shoes conforming to IS-1989:1978
- Eye and Face protection devices conforming to IS-8520:1977 and IS-8940:1978.
- Hand and body protection devices conforming to: IS-2573:1975, IS-6994:1973, IS-8807:1978, IS-8519:1977,

All tools, tackles, lifting appliances, material handling equipment scaffolds, cradles, safety nets, ladd ers, equipment's etc. used by the contractor shall be of safe design and construction. These shall be tested and certificate of fitness obtained before putting them to use and from time to time as instruc

ted by authorized Bank official who shall have the right to ban the use of anytime.

The contractor shall adopt all fire safety measures.

Where it becomes necessary to provide and/or store petroleum products, explosives, chemicals and I iquid or gaseous fuel or any other substance that may cause fire or explosion, the contractor shall st ore the same safely as per the directions of the Bank.

The contractor shall be held responsible for any violation of statutory regulations local, state or centr al and SBI's instructions, that may endanger safety of men, equipment, material and environment in his scope of work or another contractor's or agency's. Cost of damages if any, to life and property ari sing out of such violation of statutory regulations and SBI instructions shall be borne by the contractor

**36.0 INDEMNITY BOND:** Contractor shall sign an Indemnity Bond in an approved format before starting the work, indemnifying the Bank from any damages, prosecution, other legal suits and claims arising out of any mishaps occurring at the workplace due to nonadherence to safety codes, no following the standard work procedures and for violating rules and regulations for which the contractor shall be sol ely responsible.

In case of any damage to property by the contractor, Bank shall have the right to recover the cost of such damages from payments due to the contractor and decision of the Bank shall be binding on the Contractor.

In the event of any damage to the loose furniture, interiors, computers and such other equipment or to the existing building structure etc., during carrying out the contract works, the cost of repairing the same including the cost of replacement if any will be recovered from the contractor.

If the contractor fails to improve the standards of safety in its operation to the satisfaction of SBI/Ban k after being given a reasonable opportunity to do so, and/or if the contractor fails to take appropriat e safety precautions or to provide necessary safety devices and equipment or to carry out instruction s regarding safety issued by the authorized SBI/Bank official, the Bank shall have the right to take cor rective steps at the risk and cost of the contractor after giving a notice of not less than seven days in dicating the steps that would be taken by State Bank of India.

Before commencing the work, the contractor shall appoint/nominate a responsible officer to supervis e implementation of all safety measures and liaison with his counterpart of State Bank of India.

### **37.0 SETTLEMENT OF DISPUTES AND ARBITRATION:**

- a) Resolution of dispute: In the event of any question, dispute or differences in respect of contra ct or terms and conditions of the contract or interpretation of the terms and conditions or part of t he terms and conditions of the contract arises, the parties may mutually settle the dispute amica bly.
- b) Arbitration: Any dispute and/or difference arising out of or relating to this contract including int erpretation of its terms will be resolved through joint discussion of the authorized representatives of the parties. If the disputes are not resolved by discussions then the matter will be referred for adjudication to the arbitration of a single arbitrator to be appointed by mutual consent of the part ies. The arbitration proceedings shall be conducted in <a href="State Bank of India">State Bank of India</a>, Regional Business Office, Bongaigaon, Assam-783380 and in English language only and in accordance with the provisions of Arbitration & Conciliation Act 1996 or any statutory re-enactment thereof. The decision of the arbitrator shall be final and binding on the parties.
- **c) Applicable Laws:** The contract shall be governed in accordance with the law prevailing in India, Act, Rules, Amendments and orders made thereon from time to time.
- **d) Jurisdiction:** All the suits arising out of the contract shall be instituted in the court of competent jurisdiction situated in Guwahati only and not elsewhere.
- e) Saving clause: No suits, prosecution or any legal proceedings shall lie against the State Bank of India, Guwahati or any person for anything that is done in good faith or intended to be done in pursuance of tender.
- 38.0 FORECLOSURE OF CONTRACT IN FULL OR IN PART: If at any time after acceptance of the tende

r, the Employer decides to abandon or reduce the scope of the works for any reason whatsoever and hence not require the whole or any part oft he works to be carried out, they shall inform the Contract or in writing to that effect and the Contractor shall have no claim to any payment or compensation or otherwise whatsoever, on account of any loss of profit or advantage which he might have derived from the execution of the works in full, but which he did not derive in consequence of such foreclosure of the whole or part of the works. The Contractor shall be paid at the contract rates for works executed at site.

**39.0 PROPOSED WORK METHODS, SUPPLIES AND PLAN:** The Contractor shall be required to prepar e and submit a detailed description of the arrangements, sequence and methods of service performa nce which the contractor proposes to adopt for carrying out the services.

The Bank at its sole discretion shall ask at any time for changes in the anticipated work sequence due to operational requirements. Such change in work sequence shall not entitle the contractor to any additional payment.

The contractor shall be required to submit for the Bank's approval a schedule of materials that shall be mobilize for the above services wherever applicable. This information shall be submitted with full i dentification of specific manufacturer's products together with their catalogues.

The contractor shall be required to submit for the Bank's approval a detailed utilization plan and detailed manpower deployment schedule with details of manpower assigned to each task. All comments by Employer will be incorporated and executed at no extra costs to the Employer.

The contractor will schedule the cleaning operations in such a way that the premises remain neat an d clean all the time. The contractor may deploy his labourers in shifts accordingly in keeping with the prevailing labour laws of the state.

- **40.0 PRICES:** The price to be quoted by bidder shall be inclusive of all taxes and will be binding on the bi dder. In case of any change in GST or introduction of any new tax due to Statutory Act of The Govern ment after the date of submission of tenders and during the tender period, the quantum of additional taxes so levied will be allowed to be charged extra as separate without any change in price structure of the items approved under the tender. Similarly, if there is any reduction in tax etc. shall be deduct ed. Price structure will be solely dependent upon the rate approved as per work order and revisions of the same as per price variation/escalation clause mentioned in the tender. For claiming the addition al cost on account of the increase in tax structure, the bidder should produce proof from the concern ed Competent Authorities for having paid additional tax on the services provided to the Bank and can also claim the same in the invoice.
- **41.0 INSOLVENCY:** The competent authority of the Bank may at any time by giving notice in writing sum marily terminate the contract without compensation to the contractor in any of the following events, that is to say:
  - If the contractor being an individual or if firm, any partner in the contractor's firm, shall at any time be adjudged insolvent or shall have a receiving order or orders for administration of his est ate made against him or shall take any proceedings for liquidation or composition under any ins olvency not for the time being in force or shall make any convenience or assignment of his effor ts or enter into any arrangements or composition with his creditors or suspend payment of if the firm be dissolved under partnership act, or
  - If the contractor being a company shall pass a resolution or the court shall make an order for the
    e liquidation of the affairs or a receiver of manager on behalf of the debenture holder shall be a
    ppointed or circumstances shall have arisen which entitled the court or debenture holders to ap
    point a receiver or manager.
  - If the contractor commits any breach of this contract not herein specifically provided for: Provid
    ed always that such determination shall not prejudice any right of action or remedy which shall
    have accrued or shall accrue thereafter to SBI and provided also that the contractor shall be lia
    ble to pay the Bank for any extra expenditure, it is thereby put to but shall not be entitled to an
    y gain on repurchased.
- **42.0 CONFIDENTIALITY:** Information relating to the examination, clarification, evaluation, and comparis on of tenders, and recommendations for the award of a contract shall not be disclosed to bidder or an y other persons, not officially concerned with such process, until the notification of contract award is made.

Any effort by the bidder to influence SBI's bid evaluation, bid comparison, or contract award decision

s may result in the rejection of the Bidder's bid.

**43.0 CORRUPT OR FRAUDULENT PRACTICES:** The Bank as well as Bidder shall observe the highest standard of ethics during the procurement and execution of such contracts.

- a. "Corrupt practice" means the offering, giving, receiving or soliciting of anything of value to influe nce the action of a public official in the procurement process or in contract execution; and.
- b. Fraudulent practice" means a misrepresentation or omission of facts in order to Influence a procurement process or the execution of a contract to the detriment of SBI and includes collusive practice among Bidder (prior to or after tender submission) designed to establish tender prices at artificial non-competitive levels and to deprive SBI of the benefits of free and open competition.
- c. "Collusive practice" means a scheme or arrangement between two or more bidders, with or with out the knowledge of the Bank, designed to establish tender prices at artificial, non-competitive I evel: and.
- d. "Coercive practice" means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in the procurement process or effect the execution of the contract.

The Bank will reject a tender for award if it determines that the bidder recommended for award has d irectly or through an agent engaged in corrupt or fraudulent practices in competing for the contract in question.

The Bank will declare a firm or individual as ineligible, either indefinitely or for stated period of time, to be awarded a contract if it at any time determines that they have, directly or through an agent, en gaged in corrupt, fraudulent, collusive or coercive practices in competing for, or in executing, a contract.

### **44.0 PENALTIES /LIQUIDATED DAMAGES:**

- a. The Contractor shall disburse salary to its deployed manpower as per Central Govt. minimum wa ges Act latest by 07th of every month, failing which penalty equivalent to one-day salary (Basic + DA) per delayed day shall be credited by the contractor into the account of the respective emp loyees whose salary has been delayed, apart from his regular remuneration which the contractor is payable to him. Proof of the same accompanied by the attendance sheet, salary slips, wage re gister, EPF statements &EPF challan &EPF TRRN payment confirmation receipt and ESI statement s and ESI challan copy of the preceding month of the contract labours shall be submitted to the B ank along with the bills, sealed and signed by the Contractor or the respective signatory as per b oard resolution(if applicable)before 15<sup>th</sup> of the next month. If such scenario continues for a perio d of 3 continuous months, then the contract shall be liable to be terminated. Security Deposit /Pe rformance Bank Guarantee shall be forfeited and Bank guarantee shall been cashed. The Bank wi Il have the power to appoint any other agency for the manpower services at the risk and cost of the Contractor.
- **b.** The Contractor has to maintain adequate number of manpower as per this contract and also arra nge a pool of standby manpower/supervisor. If the required numbers of manpower/supervisors are less than specified number as mentioned in the contract, a penalty of Rs.1000/- per absentee per day shall be deducted from the bill(s).
- c. In case of breach of any conditions of the contract and for all types of losses caused including exc ess cost due to hiring manpower services in the event of Contractor failing to provide requisitioned number of manpower, the Bank /SBI shall make deductions at double the rate of hiring rate on pro-rata basis from the bills preferred by the Contractor or that may become due to the Contractor under this or any other contract or from the security deposit or may be demanded from the Contractor to be paid within seven days to the credit of the Bank /SBI.
- **d.** An amount of Rs.3000/- will be levied as liquidated damages per day from the Contractor whene ver and wherever if found that the work is not up to the mark. If the Contractor fails to perform as per the satisfaction of SBI within 15 days, liquidated damages clause as incorporated in the tende r document of the Contractor by Bank will be invoked.
- **e.** Under any circumstances the collected wastes should not be burnt or dumped inside the campus . In case of any such observation by the Bank, the Contractor shall be penalized up to 5% of the monthly Bill amount which will deducted from any bills/dues of Contractor.

Bank reserves the right to revise the rate/quantum of penalty to be levied based on assessment by the Bank for non-conformity/deviation of the above.

### **45.0 PRICE VARIATION CLAUSE:**

The rate quoted against service charge in price breakup format by the bidder shall remain fixed and valid for the entire contract period. No escalation/price increase whatsoever shall be considered during this period for this part. Accordingly, contractor has to take due care on this account while quoting the rates.

For the Manpower cost part, which is prefilled in the price breakup format, c onsequent upon revision of rates of VDA/ Minimum wages by Govt. notification or Amendments in Labour Laws, coming into ef fect after submission of price bid, if any, and during the currency of the contract, the Contractor shall be reimbursed by SBI for additional expenditure due to such change. However, revised VDA payment will be exclusive of any effect on the service charge.

Such reimbursement by Bank shall be subject to production of documentary evidence by the Contrac tor of making such payment to the contract labour and depositing with the statutory authorities wher ever required, to the satisfaction of Bank and to the extent where such payment is directly attributed to change in VDA / minimum wages and all social security benefits by Govt. Notification / amendmen ts in Labour Laws.

**46.0 VALIDITY OF CONTRACT:** The contract, if awarded shall be valid for a period of 2 (Two) year from the date of commencement of work. In case of breach of contract or in the event of not fulfilling the minimum requirements/statuary requirement/satisfactory services etc., the Bank shall have the right to terminate the contract forth with at any time in addition to forfeiting the performance security am ount deposited by the contractor and initiating necessary action as deemed fit including de-paneling your firm etc. solely at the discretion of the Bank.

The Contractor, even after the expiry of the period of contract will have to provide the service at the discretion of the Bank for a period of another 3 (Three) months or till the selection of the new contractor by the bank whichever is earlier on the same rate and terms and conditions. The Contractor may, after giving three months' notice to the Bank in advance to terminate the contract, if he so desires at any time during the course of the currency of this agreement.

The Contract will be subject to renewal for another 1(One) year upon satisfactory performance with s ame rate and terms & conditions of the tender, subject to the sole discretion of the bank. The extensi on/renewal of contract is to the entire discretion of the Bank and cannot be claimed as right of the Contractor.

- **47.0 ASSIGNMENT AND SUBLETTING:** The Contractor shall not assign or sublet the benefits of this cont ract to any person or entity and in the event of any violation or breach thereof, the Bank may at its di scretion but without prejudice to its other rights and remedies terminate this contract.
- **48.0 SEXUAL HARASSMENT:** The Contractor shall be solely responsible for full compliance with the pro vision of the "the Sexual Harassment of women at workplace (Prevention, Prohibition and Redressal) Act, 2013"
  - In case of any complaint of sexual harassment against its employee/s, the complaint will be file d before the Internal Complaints Committee constituted by the Contractor and the contractor s hall ensure appropriate action under the said Act in respect to the complaint.
  - Any complaint of sexual harassment from any aggrieved employee of the State Bank of India (SBI) against any employee/s of the contractor shall be taken cognizance of by the State Bank of India (SBI).
  - The contractor shall be responsible for any monetary compensation that may need to be paid in case the incident involves the employees of the contractor, for instance any monetary relief to Bank's employee, if sexual harassment/violence by the employee of the contractor is proved.
  - · The contractor shall be responsible for educating its employees about prevention of sexual har assment at workplace and related issues.
- **49.0 NON-DISCLOSURE:** The Contractor shall not disclose directly or indirectly any information, material s and details of the State Bank of India's infrastructure / systems/ equipment etc., which may come t o the possession or knowledge of the Contractor during the course of discharging contractual obligati ons in connection with this agreement, to any third party and shall at all times hold the same in strict

est confidence. The Contractor shall treat the details of the contract as private and confidential, exce pt to the extent necessary to carry out the obligations under it or to comply with applicable laws. The Contractor shall not publish, permit to be published, or disclose any particulars of the works in any tr ade or technical paper or elsewhere without the previous written consent of the State Bank of India (S BI). The Contractor shall take all appropriate actions with respect to its employees to ensure that the obligations of non-disclosure of confidential information under this agreement are fully satisfied. The Contractor's obligations with respect to non-disclosure and confidentiality will survive the expiry or te rmination of this agreement for whatever reason.

The contractor's shall be bound to comply the following provision in terms of "Restrictions impose d by the Government of India, Ministry of Finance Department of Expenditure under Rule 144 (XI) of General Financial Rules 2017vide their order no. F. No 6/18/2019/PPD dated 23 rd July 2020" as under:

- a. Any bidder from a country which shares a land border with India will be eligible to bid in this tend er ONLY if the bidder is registered with the Competent Authority (registration committee constitut ed by the Department for Promotion of Industry and Internal Trade).

- **1.0 SERVICES:** Contractor to provide manpower for housekeeping and maintenance services of the pre mises. The contractor shall be responsible for performance of under noted duties:
- **1.1 Daily Cleaning:** Cleaning, Dusting, Sweeping, and mopping of toilets, cabins, chambers, Banking Hall, pa ssages, pantry, canteen, Stairs, floors, storerooms, record rooms, Glass walls, parking area, changing rooms, lunch rooms, recreation room, A.H.U. rooms, ducts, etc. All furniture Computers, UPS, Printers, Telephones will be cleaned to keep dust free with dry cloth/brushing.

### 1.1.1 Sweep & Clean

- a. Sweep and clean all floors with broom.
- b. Wet moping of tiles, vitrified floors, staircases, elevators, floor, sidewalls and podium entrance ar
- c. Floors shall be cleaned free of stain, dirt, mud, sand, footprints, liquid spills, and other litters with out damaging.
- d. Chairs, computers, keyboards, trash, receptacles, and easily movable items shall be moved to cl ean underneath.
- e. During inclement weather, the frequency of cleaning may increase depending on the situation. W hen completed, the floors and halls shall have a uniform appearance with no streaks, smears, swi rl marks, detergent residue, or any evidence of dirt remaining or water standing.
- f. After sweeping all vitrified floors, areas will be wet mopped with water mixed with disinfectant, cl eaning agent for proper hygiene & shine.
- g. Sweep clean of debris from walkways and driveways and hose clean them during appropriate we ather and water use conditions.

### 1.1.2 Vacuuming

- a. Vacuuming all carpets, runners and carpet protectors so that they are free of dust, dirt, lint, mud,
- b. Heavy industrial type vacuum cleaner should be used to ensure adequate cleaning. When completed, the area shall be free of all litter, lint, loose soil and debris.
- c. All chairs, trash receptacles, and easily moveable items shall be moved to vacuum underneath, a

nd then replaced in the original position.

### 1.1.3 Washroom cleaning including lady's toilet (to be carried out twice daily)

- a. Thorough cleaning and sanitization of toilets, bathrooms, wash basins and shower facilities, using suitable non-abrasive cleaners and disinfectants.
- b. All surfaces shall be free of grime, soap, mud and smudges.

### 1.1.4 Trash removal

- b. All waste collected from wastepaper baskets will be deposited in the dedicated waste containers placed at the specified position of the building.
- c. Dry & wet garbage would be segregated and dumped into designated area within the premises.
- d. Collection of old newspapers, bundling & shifting to specified place.

### 1.1.5 Glass Surface Cleaning

- a. All glasses at entrance doors of the premises would be cleaned using damp and dry method.
- b. Glass tabletops, cabin doors, cabin partitions and glass accessories would also be cleaned.
- c. Removal of grease marks or fingerprints on glass counters and partitions. This cleaning is done u sing approved all-purpose cleaner and lint free cloth or paper towels.

### 1.1.6 Spot Carpet Cleaning

a. Spot clean carpets whenever necessary to remove stains, using appropriate products, chemicals, etc.

### 1.1.7 Damp & Dry Cleaning

- a. Wipe clean all white boards of meeting rooms, conference rooms, workstations, etc.
- b. Wipe clean all table tops of workstations, cubicles and other furniture and fixtures.
- c. Conference Rooms including table and chairs.
- d. Cleaning includes cleaning of Glass Façade, ceiling, marble cladding, carpets, chairs, Service Roo ms/ bath/ toilets, etc.

### 1.1.8 Pantry Service:

Pantry service shall include providing tea and/or coffee and/or drinking water to staff/officials at Bran ches/ Offices/ Residential complexes as and when required.

### 1.2 Weekly Cleaning and Other Works

### 1.2.1 Deep Cleaning

- a. Stairways, surrounding common areas, terraces, generator rooms, AHU Rooms, basements, car p arking, etc.
- b. Ceilings, walls, partitions, etc.
- c. Toilets and washrooms.

### 1.2.2 Window Glass Cleaning

a. Interior & Exterior glasses will be cleaned on both sides.

- b. Exterior cleaning of the glasses where accessible.
- c. Dusting windowsills and blinds.

### 1.2.3 Sanitizing

- a. Office desk paper bins would be cleaned and sanitized though the same are also to be cleaned da ily.
- b. All washroom dustbins would be thoroughly cleaned and sanitized.
- c. All telephone instruments would be sanitized using disinfectants.
- d. Waste bins from Pantry and Cafeteria areas would also be thoroughly cleaned and sanitized with disinfectants.
- e. Thorough washing of all walls and doors of all toilets with appropriate detergent and disinfectant.

### 1.3 Fortnightly Cleaning and Other Works

### 1.3.1 Cleaning, Dusting and Wiping

- a. Cleaning, dusting, and wiping of Electrical items such as Lamp, tube lights, electrical fittings etc.
- b. Cleaning, dusting and wiping of sanitary fittings in the Washroom, ladies' toilets etc.
- c. Cleaning, dusting and wiping of Handles, doors, door closers, fittings, windows, curtains etc.
- d. Cleaning, dusting and wiping of false ceilings, and false ceilings of all lifts.
- e. After Cleaning, dusting and wiping of various items, these shall be free from dirt, grime, dust and marks.
- **1.3.2 Polishing:** All the door handles /doorknobs, hand railings, lift walls, other brass fittings are re quired to be polished and kept in shining condition by using good quality polishing agents.
- **1.3.3 Scrubbing:** Scrubbing of all floor areas with scrubbing machines.

### 1.4 Quarterly Cleaning and Other Works

### 1.4.1 External Façade:

a. Besides undertaking cleaning of the glasses and glass panes on daily / weekly basis as stated ab ove, the Contractor shall also undertake cleaning of glasses and glass panes, glass windows by e ngaging suitable and safe measure every three months. It will be the responsibility of the Contra ctor to ensure that necessary insurance cover is obtained well in advance for their employees.

### 1.4.2 OTHER REQUIREMENTS TO BE PROVIDED BY THE CONTRACTOR

- a) Movement of furniture and other articles from one place to another within the premises would be provided by the Contractor.
- b) If the Bank suffers any loss on account of non-performance or on account of any act of commission or omission on the part of the Contractor or the perso ns engaged by him or by reason of his negligence or misconduct in the due di scharge of the duties, the Bank will be entitled to recover the loss from the C ontractor.
- c) The Contractor shall bear all costs and expenses in respect of all charges, st amp duty, etc. in respect of all Agreements that may be entered into with the Bank to give effect to this agreement and also in respect of Agreement that may be entered into at a later date.
- d) The Contractor shall alone bear all the taxes, rates, charges, levies or claims whatsoever as may be imposed or levied by the State/ Central Government(s) ) or any local body or authority for and in connection with the rendering services.

- e) The Contractor should possess, for the entire duration of the contract, all the licenses and registrations as may be required under any law and shall be res ponsible to register himself and obtain a valid license under Contract Labour (Regulation& Abolition) Act, 1970 and comply all the statutory Laws including provisions of Section 16, 17, 18, 72 and 73 of the CL(R&A) Act, 1970.
- f) The contractor would employ separate set of his/her/their own personnel in t he age range of years from 18 to 50 years with sound physique free from an y contagious disease. They shall also be provided with appropriate uniforms, shoes and identity cards by the Contractor at his own expenses, and the Con tractor shall ensure that the workers/labourers are in the complete set of unif orm, shoes and identity cards while they are on duty. Any default will lead to penalty per person out of uniform.
- g) The workers/labourers will be the workmen of the Contractor only and there shall be no relation of employee & employer, master & servant etc. between the bearers/ waiters/ workers engaged by the Contractor & the Bank. In no ca se they shall claim to be the employees of the Bank. Nor they shall claim their wages/ any compensation etc. from the bank as they shall be the sole responsibility/ liability of the Contractor.
- h) The Contractor shall have to engage the services of only major, able, efficien t, healthy, honest and well-behaved labour /workers at his cost and responsib ility. These persons shall be considered for all legal and contractual purposes as the employees of the Contractor himself. The Contractor will have full con trol and responsibility for the service conditions, wages, claims, damages, co mpensation, etc. in respect of employees appointed by him and will also be r esponsible for the due compliance with all the requirements of all statutory o bligations and to pay all claims, costs, damages, expenses, fine or penalties, which may arise out of any claims, suit or prosecution for contravention there of. The Contractor shall comply with all the statutory laws and local laws like Labour Laws, Payment of Minimum Wages Act, ESI, Employee's P F Act, Insur ance Act, etc and the Contractor undertakes, accepts and admits absolute an d complete responsibility for service conditions etc as said herein.
- i) The Contractor shall arrange and pay for policy under the Public Liability Insu rance Act, 1991 & ensure and keep insured contractor's all materials which a re or have been declared to be hazardous under the notifications issued or th at may be issued from time to time under the above said Act or any Rules fra med there under, and which are used by the Contractor during the course of the services under the contract. The Contractor shall also obtain adequate all risk insurance policy in respect of his workmen engaged for the service, towa rds meeting the Liability of compensation arising out of death, injury/ disable ment at work etc. & shall regularly and punctually pay each and every premi um as & when the same shall become due during the currency of the contract and provide a copy to the Bank for record.
- j) No living quarters will be provided by the Bank for the workers. The Contract or will also ensure that his staff does not trespass the office/hostel premises e xcept while on duty.
- k) The Bank reserves the right to review/modify/ alter/ amend all or any of the a foresaid clauses at any time without assigning any reason thereof and the Co ntractor agrees to the same.
- In case, any deficiency noticed in the required services, due to short deploy ment of any manpower, necessary remedial deductions will be imposed as p er special conditions of the contract. If the recurrences of inadequate deploy

ment of manpower happens repeatedly, even after imposing remedial deduct ions, then such type of act will be considered as 'unsatisfactory performance' and necessary action will be initiated as per the contract terms & conditions.

- m) The reservation for SC/ST/OBC for deployed staffs should be as per Government rule.
- n) Anyone found unsuitable in his actual performance will be liable for a change
- o) All personnel should submit medical fitness certificate.
- p) All personnel should have working and speaking knowledge of Hindi and loca I language.
- q) All above staff should be uniformed with shoes and Identity Cards. They, including scavenger, should wear neat and clean dress. Nobody will move in duty hours in dirty dress.

Contractor shall get Character & Antecedents verification certificate from the Police as required by Bank, for their personnel before the commencement of contract and prior to deploy any new persons against replacement/requireme nt for this service. Necessary approval prior to the deployment shall be obtained from Bank officer in charge.

a. Vehicle driving as and when required.
