- 1. The disposal of vehicle shall be strictly on "AS IS WHERE IS AND WHATEVER IS BASIS" and no guarantee or certificate of its worthiness or quality will be given by the Bank. The condition of the vehicles can be inspected physically between 11.00 AM to 4.00 PM on any working day between 03/04/2025 to 24/04/2025 at State Bank of India, Learning & Development Center, Vidhyadhar Nagar, Jaipur.
- 3. Bidders need to submit **earnest money for Rs.25,000/- per vehicle each**. The earnest money can be deposited by Bank Draft / Banker's Cheque/ Pay order in favor of "Astt. General Manager (P&E), State Bank of India, Jaipur". The Bank Draft/ Banker's Cheque/ Pay order should be attached with the quoted bid, failing which the bids will not be considered at all. If the highest Bidder/ successful Bidder fails to deposit the sale price within 15 days, his earnest money will be forfeited. In case the offer is withdrawn by any tenderer, the earnest money deposited by him shall be forfeited.
