Payment of vendors/ suppliers' bills will be made on satisfactory completion of work at site duly certified by Branch and Bank's Engineer.

Delivery, installation and embedding etc of the products to be inclusive of all cost at site complete. Vendors/ supplier if so, desire can involve their authorized dealers for execution of orders on the same terms & conditions and prices.

Vendors/ suppliers/ dealer will take the entire responsibility of making good of any kind of damage to the equipment/structure which may occur while doing the placement job and no extra cost will be paid. Should there be any mishap /causality while executing the work, the responsibility of any kind of nature lies with the vendor/ supplier/ dealer.

The vendor/ supplier to comply with the delivery schedule as given below: -

I) Delivery, installation and embedding of safe within 15 DAYS from the date of confirmed order by RBO /Branch.

Payment of vendors/ suppliers' bills will be made on satisfactory completion of work at site by the concerned branch/ RBO after duly being certified by Branch & Bank's Engineer.

#### TERMS ANDCONDITIONS

1. Vendors / Contractors / OEM Manufactures representatives must visit the site before quoting their rates and acquaint themselves to the site conditions / floor level/ access to place of installation / staircase & door widths etc as no extra claim will be entertained on account of any reason whatsoever.

2. The quantities in the tender are indicative for rates only and can vary as per BANK'S requirement in the Branch, no compensation of any kind will be paid, and the contractor shall have to carry out such variation at the quoted rates. Bank reserves the right to increase/ decrease any quantity or part of the work for which no claim shall be entertained.

**3.** Rates should be complete for all connected works of the item, all type of materials, tools scaffolding, lead, lift, and disposal of garbage complete in all respect. Rates should be inclusive of all taxes and shall remain firm. However, rate should be exclusive of only GST, which will be paid over and above at applicable rates.

4. All rates shall be firm and not subject to variation in prices whatsoever and shall remain valid for one year.

5. Bank will not arrange any Labour, material, tools and plant and scaffolding etc. required for the execution of the job.

6. The quotation shall remain open for acceptance for a period of 60 days from the date of opening.

7. Work shall have to be completed within 15 days from the date of work order. In

case of delay by the vendor, penalty @ 0.5% per week, subject to maximum of 5%, shall be imposed. Bank may however extend time limit in deserving cases for which request shall have to be made in writing well in time.

8. Conditional tenders are liable to be rejected and Bank is also not bound to accept any or the lowest quotation without assigning any reason whatsoever. The lowest quote will be the base value for the reverse auction or as decided by the tender opening Committee. The decision of the Bank in this regard and for accepting / rejecting any quotation shall be final.

9. All the Indicative Price Bids of tenders on the prescribed Performa (enclosed) are to be submitted ON-LINE. The Offer should be accompanied with the requisite earnest money (enclosed in a separate envelope) to be submitted at RBO.

10. Bank shall not be responsible for any loss or damage due to any reasons whatsoever till the work has been completed and handed over to the Bank in all respects.

11. Based on the tentative Price bid, reverse auction will be got carried out by E-Auction Agency, M/s TENDER WIZARD over a period of 30 mins with maximum up to 6 extensions of 5 mins each with decremental value of Rs. 5000/- each during reverse auction. Decision of the Bank based on lowest quote received after reverse auction in this regard shall be final and binding.

12. No advance Payments shall be made.

13. Contractor shall have to give his program of work well in advances that if considered necessary by Bank's so that Bank may depute his representative.

14. Successful bidder must COMPLETE the job within 15 days from the date of letter of intent. If the bidder fails to start the job in this period, Bank reserve right to cancel the work order and forfeit earnest money.

17. Income tax, WCT, TDS ON GST or any other tax in accordance with tax regulations shall be deducted from payments to be made to contractor.

18. If contractor fails to complete the work in stipulated time frame, then the Branch / RBO/ Bank's Engineer reserves right to get the remaining portion of work to be got done from any other agency at the risk and cost of the contractor in addition to forfeiture of earnest money.

**19.** The Bank reserves right to reject any or all the TENDERS without assigning any reason thereof.

3	The OEM must possess Valid BIS License to manufacture and supply the aforementioned TRTL safes (Class AAA).		
4	All the surfaces of the safes before painting shall be		

	thoroughly degreeped and elegened of much and each-		
	thoroughly degreased and cleaned of rust and scales		
	preferably by 12 tanks pickling process and treated chemically		
	to prevent from rusting.		
5	The Safe shall be painted inside and outside with an anti-

**Note:** For any additional features provided by the vendor, no additional cost will be paid. In case of any conflict in the technical specifications mentioned above, the prevailing technical specifications as per latest IS 550 (part-1,2,3) of BIS shall be final.

### ADDITIONAL TERMS & CONDITIONS

1. The Vendor shall have the responsibility of complying with the local shops/establishments Act, Labour Insurance and other labour/minimum wages Act and shall keep all such records/accounts on payment of wages/attendance as deemed necessary.

2. **Árbitration**: As per the Bank's standard arbitration clause under the Jurisdiction of Delhi.

3. **Organization**: The Vendor shall employ competent/qualified supervisor/Engineer-in-Charge who shall be responsible for the supply and installation of the product at site.

4. **Damage to Property**: Any Damage to the Bank's property during the installation will be recovered from the vendor.

5. The Vendor should be registered under GST, failing which the tender will be rejected.

6. **Deduction**: Tax at source as per IT Act.

7. **Terms of payment**: Payment after completion of total tender order by the respective branch after taking necessary approval from Regional Business Office.

8. **Billing procedure**: All Bills/invoice shall be submitted in the name of State Bank of India, GST no. 07AAAACS8577K1ZR, Name of the Branch Office along with acknowledgement of delivery and Installation to the satisfaction of Branch / Bank Engineer. No interims payment shall be allowed.

9. In case of failure to take up the supply of product even after accepting the purchase order, or leaving the order incomplete, or for defective product, or violation of the terms and conditions, the Bank may take suitable action against the vendor as appropriate.

10. The vendor shall have to make their own arrangement for transportation, installation and placement of the Gold safes inside the designated place of Branch including RCC encasing as per standard specification at their own cost.

11. In case of breach of contract by the vendor for slow progress or any other claim of damage, the Bank / Bank Engineer have the authority to re-assign the contract to any vendor to complete the work without assigning any reasons thereof.

12. The Employer shall not be liable for any damages or compensation payable as a consequence of any accident or injury to any workman or other persons during the process of execution of the order.

13. On completion of the order, all rubbish, debris, materials, tools etc. to be removed by the vendor from the site and will hand over the site clean and clear and in usable condition failing which, the employer may dispose the materials at the cost of vendor.

14. In case of any dispute, the matter will be referred to the Regional Manager, State Bank of India, RBO-1, 23, 2<sup>ND</sup> Floor, Najafgarh Road, New Delhi - 110015.

15. The rates quoted in the tender shall include all the taxes, no escalation of rates will be allowed under any circumstances.

16. The tender will be awarded to the lowest bidder after reverse auction.

17. The bidder is required to submit, along with the Bid, all relevant certifications such as BIS license, test certificate, approved certificates and other certificates as prescribed in the Product Specifications given in the Bid document.

18. All the OEMs/Dealers of empaneled OEMs are required to submit an indemnity bond on stamp paper of Rs. 10/- only that their product is strictly as per latest ISO 550(Part-1,2,3) of BIS.



EMBEDMENT OF SAFE

- 1. Base: RCC, M 20, minimum 300 mm thick (out of which 150 mm below the floor level). The thickness can be increased as per need and would depend upon the height of the safe.
- 2. Sides + Top + Back: RCC, M 20, 150 mm thick
- 3. Reinforcement: 12 mm diameter bars 100 mm centre to centre both ways in single layer.
- Finishing: 10 12 mm thick plaster with 1:3 mix mortar (one part cement: three part sand) on exposed surface and painting to match the décor of the room.
