- 5. SBI reserves their rights to accept any or to reject all the tenders in part or whole without assigning reasons thereof and no correspondence shall be entertained in this regard.
- 6. The interested vendors shall submit the documents/testimonials pertaining to eligibility criterion along with the technical bid, only the eligible bids will be opened.
- 7. Tenders can be downloaded from <u>https://etender.sbi</u>. It shall be the responsibility of the Vendor to arrange and ensure that all pages of technical and financial bid are properly bound separately. Tenders in loose pages shall be disqualified.
- 8. The L-1 Vendor (successful bidder) shall sign and stamp each page of the tender document thereby ensuring the number and sequence of all pages after completion of the tendering procedures.
- 9. Conditional tenders shall be summarily rejected.
