Tenders with incomplete or broken seals are liable to be rejected, the matter solely resting at the discretion of the EMPLOYER. If a Contractor does not quote for one or more items, the Tender will be considered as incomplete and will be rejected.

2. The EMPLOYER reserve to itself the right to accept or reject any tender without assigning any reason for doing so and does not bind itself to accept the lowest or any other tender.

3. General Specifications are for guidance only. The latest ISI codes and Specifications and mode of measurements will be referred to during execution.

4. Employer shall mean **SME Saraswathipuram**

5. Rate excluding GST but including cost of materials, labours, formworks, scaffolding, wastages, loading, unloading & transportation etc., Bank will not pay anything extra other than quoted rates.

6. Necessary test report to be submitted along with final bill for payment.

7. Committee will finalize the brand of approved make on submitting samples from all approved brands by the L1 vendor.

8. Specialized works like water proofing, anti- termite treatment, UPVC windows etc. has to be carried out by the authorized agencies of approved make/brand/ company.
