State Bank of India invites application for empanelment of Contractors/Vendors for undertaking Civil works including Plumbing & Sanitary; Repairs & Maintenance works (Civil Works, Sanitary & Plumbing) in different categories as under, separate for Bank's branches/offices and residences spread over entire State of Kerala including Mahe & Lakshadweep under the Thiruvananthapuram Circle of State Bank of India. The Contractors/Vendors with necessary experience in the respective category and those who fulfill the eligibility criteria will be considered for the empanelment.

- A. *Definition of similar works (as per Annexure A) means qualitative successful completion of WORKS of specified magnitude (as per Table-A) for Central Government Department / State –Govt Dept/ Semi Govt dept/ PSU / MNC'S which are acceptable to Bank/Nationalized Banks/ Reputed Institutional Organization/

 Large Private sector establishments/ etc. The information must be supported with the copies of Work Order, Satisfactory Completion Certificate, Proof of payment/Form 26 AS etc.
- B. (**) Applicants should have minimum average annual turnover prescribed in the Table-A during last 3 financial years ending on 31.03.2025 and submit Solvency of specified value issued by any Scheduled Bank. The Solvency Certificate should not have been issued prior to 1st of February 2025.
- C. The applicant shall be either a company, partnership firm or a proprietorship concern having its registered office/functioning office in the State of Kerala.
- (2) The average annual turnover of Contractors (Civil works) during last 3 years ending 31.03.2025 should be at least 30% of the upper value of the category in which they wish to apply.
- (3) The applicants should submit Solvency of specified value issued by any Scheduled Bank. The Solvency Certificate should not have been issued prior to 01.02.2025.
- (4) The eligibility criteria should be in the name of the applicant/firm only.

- (5) The Contractor is required to furnish their PAN No, GSTN Registration details of firm with GSTN No. with relevant copies of the documents.
- (6) The Contractor must comply with the rules and regulations for EPF, ESI and the Labour license etc. under the Contract Labour Rules and Regulation Act/any other rules or acts applicable for the above purpose.
- (7) The Bank usually conducts online reverse auction/e-tendering and hence Contractor must possess valid E-mail ID, Mobile No and Digital Certificate etc. for participation in the online events.
- (8) For Assessing the Annual Turnover of the last 3 financial years ending on 31.03.2025, Contractor must submit valid documents viz. Copy of Income tax return, Copies of IT assessment order, Profit & Loss Account and Audited Balance sheet for the last 3 years w.e.f FY 2021-22. Provisional balance sheet for the FY-2024-25 must also be submitted.
- **(9) MSE Firms Exemptions**: The firms applying under MSE category must be registered under Central Govt., in relevant category and will be exempted from (i) Turn over (ii) Experience in works; however, the firm should be well established for a minimum period of 3 years and fulfill all other terms & conditions.
- (10) Startups Exemptions: The firms applying under startups category must be registered with Govt. of India., in relevant category and will be exempted from (i) Turn over (ii) Experience in works (iii) Establishment, however, the firm should fulfill all other terms & conditions.
- (11) If the applicant is under MSE or Startups category as per clause no. 9 & 10, it shall be considered for empanelment in the basic category (i.e, the firms who are exempted under MSE/Startups shall be eligible for works up to 5 lakhs category only). The valid registration certificates is mandatory.

- a. Building repairs i.e (minor civil works, plastering work/Seepage & Leakage treatment/Painting work etc)
- b. Annual Maintenance Contract for sanitary and plumbing works at offices/residential buildings. Plumbing repairing works /Cleaning works etc
- c. Renovation work i.e Supply and installation of vitrified tiles/antiskid tiles/ceramic tiles/sanitary fittings after removing existing tiles/ external & internal sewerage pipelines.

Contractors must submit the sufficient documentary evidence/work orders/Satisfactory completion certificates, etc. meeting the above-mentioned criteria from the Nationalized Banks / reputed Institutional Organization/ Large Private sector establishments/ PSUs/ Central & State Govt. Departments etc. regarding satisfactory performance of works completed during the last 7 years. For private works the Contractor must submit necessary proof of payment/ Form 26 AS.
- 3. Firm/Organization need not to apply for each category (Job value) of a specific work (e.g Civil Works, Repairs & Maintenance works) separately. The firm/organization applying for higher category will also be eligible to the lower category.
- 4. The Bank reserves the right to carryout physical inspection of works mentioned by the applicants in their application forms in addition to calling for confidential reports from the respective employer/departments to ascertain their capability, quality of works, genuineness of the documents submitted and such other relevant information which the Bank's deems necessary.
