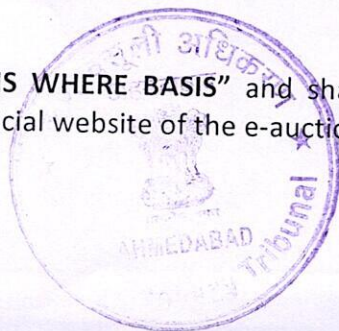
EMD deposited thereafter shall not be considered for participation in the e-auction.


