The Bidders should get themselves registered on https://BAANKNET.com by providing requisite KYC documents and registration fee as per the practice followed by https://BAANKNET.com well before the auction date. The Intending bidder should transfer his EMD amount by means of challan generated on his bidder account maintained with https://BAANKNET.com by means of NEFT/ RTGS transfer from his bank account.</p> <p>(c) The Intending bidder should take care that the EMD is transferred at least one day before the date of auction and confirm that his wallet maintained with https://BAANKNET.com is reflecting the EMD amount without which the system will not allow the bidder to participate in the e-auction.
