The Bidders shall hold a valid digital Signature Certificate issued by competent authority and valid email-id is absolutely necessary for the intending bidder as all the relevant information and allotment of ID and Password by <b>M/s PSB Alliance Private limited</b> may be conveyed through email.</li> <li>2. Names of Eligible Bidders will be identified by the State Bank of India, Stressed Assets Recovery Branch (SARB) Jabalpur Branch to participate in online e-Auction on the portal <a href="https://baanknet.com">https://baanknet.com</a> M/s PSB Alliance Private Limited will provide user ID and Password after due verification of PAN of the Eligible Bidders.</li> <li>3. The successful bidder shall be required to submit the final prices, quoted during the e-auction as per the annexure after the completion of the auction, duly signed and stamped as token of acceptance without any new condition other than those already agreed to before start of auction.</li> <li>4. During e-auction, if no bid is received within the specified time, State Bank of India at its discretion may decide to revise opening price/ scrap the e-auction process/ proceed with conventional mode of tendering.</li> <li>5.
