- (6) Only buyers holding valid User ID / Password and confirmed payment of EMD through NEFT / RTGS shall be eligible for participating in the online auction process.
- (7) The interested bidders who have submitted their EMD below 10% of reserve the price https://baanknet.com shall be eligible for participating in the E-Auction. The E-Auction of above properties wold be conducted exactly on the scheduled date & time as mentioned above by way of inter-se bidding amongst the bidders. The bidders shall improve their offer in multiple of amount mentioned under the column "Bid Increase Amount" against the Property in case bid is placed in the last 5 utes of the closing time of the E-Auction, the closing time will be automatically get extended for 5 minutes (subject to unlimited extensions of 5 minutes each).
