- iii. Cover-II: Shall contain the Part-II (BOQ) of this tender with all rows and columns duly filled and signed with sealed stamp.
- iv. Cover-I will be opened on 13.05.2019 at 12.00 Noon in the presence of Tenderers who desire to attend.
