(e) During e- Auction, if no bid is received within the specified time, State Bank of India at its discretion may decide to revise opening price/ scrap the e- Auction process / proceed with conventional mode of tendering.

(i) Decision of the Authorised Officer regarding declaration of successful bidder shall be final and binding on all the bidders.


(j) The Authorized Officer shall be at liberty to cancel the e- Auction process/ tender at any time, before declaring the successful bidder, without assigning any reason.
