d) The Successful bidder shall be required to submit the final prices, quoted during the –e Auction as per the annexure after the completion of the e- Auction, duly signed and stamped as token of acceptance without any new condition other than those already agreed to before start of e- auction.

e) During e- Auction , if no bid is received within specified time, State bank of India at its discretion may decide to revise opening price/ scrap the e- Auction process / process /proceed with conventional mode of e tendering.

p) The successful bidder shall bear the applicable stamp duties/ additional stamp duty/ transfer charges, Registration expenses, fees etc. for transfer of the
