SBI Infra Management Solutions Pvt. Ltd. Application is invited from interested tanker water suppliers for supplying tanker water at various offices/residential quarters of SBI across Chennai city fulfilling the under mentioned eligibility criteria.

1. Instructions to applicants: Interested agencies are requested to read the following eligibility criteria, terms and conditions for self-assessment and furnish the details as desired.

Envelope 1: Technical Bid - Duly filled application along with supporting documents, EMD & Tender processing fees.

Envelope 2: Price Bid - Duly Filled price bid in the given format.

Both the envelopes shall be submitted in a sealed cover super-scribing "Application for empanelment & selection of agencies for supplying tanker water at various offices/residential quarters of SBI across Chennai city" duly completed in all respects to the address mentioned above.

2. Eligibility Criteria (to be supported by documentary evidence):

- a. Reputed agencies who have Government authority's permission to supply tanker water in Chennai shall alone apply.
- b. Average annual financial turn over during the last 3 years ending 31.03.2018 should not be less than **Rs. 8.00 lakhs.** (**Duly certified by CA**)
- c. The firm should have at least **04 nos. of tanker vehicles of minimum 24,000 litres capacity** each supported by Registration Certificate (RC) with validity of not more than 10 years and valid Fitness Certificate (FC).
- d. Application processing fees in the form of Demand Draft (DD) for **Rs. 2,000/-** (Rupees two thousand only) favouring "**SBI Infra Management Solutions Pvt. Ltd.**" payable at Chennai (Nonrefundable).
- e. EMD in the form of Demand Draft (DD) for **Rs. 20,000/-** (Rupees twenty thousand only) favouring "**State Bank of India**" payable at Chennai towards EMD. (Refundable within two weeks to the unsuccessful bidders).

3. Evaluation:

- a. Applications shall be evaluated based on the predefined eligibility criteria, verification of credentials etc. Thus qualified will be called as "Empanelled agencies for supplying tanker water at various offices/residential quarters of SBI across Chennai city".
- b. The panel will be in force for three consecutive years from the date of approval, during which Price/Commercial bids shall be invited only from them to meet Bank's ensuing requirement.
- c. Envelope 2 i.e. Price bids of only prequalified/empanelled agencies shall alone be opened and considered for evaluation.
- d. Based on the no. of loads required on each day and the capacity of the L1 to meet the requirements of all locations in time, Bank reserves right to place order with L2 & L3 suppliers at L1 rate without assigning any reasons thereof.





TERMS AND CONDITIONS

- 1. Water shall be suitable/fit for domestic consumption with permissible physical, chemical & biological characteristics as per relevant **IS standards.** Bank reserves right to send a water sample from any delivery point randomly at any given point of time. Test certificate certifying the quality of water for domestic purpose from an accredited laboratory as nominated by the Bank shall be submitted as & when mandated. Cost of water testing charges shall be borne by the supplier.
- 2. Water tanks shall be made of material suitable for storage of water and shall be in fresh & clean condition ensuring turbid free and unchanging the quality of water being transported for domestic use. The access must be covered with a dust-proof lockable cover. The air vent with an outlet shall prevent dust, insects, birds and other vermin entering the tank. Hoses and related couplings shall be stored in a sealed container to protect them from contamination. Pumps & other related equipment/accessories shall be in good condition & neatly maintained.
- 3. Water sourcing point shall be inspected by the Bank at any time during currency of contract to ensure that the water is drawn only form the approved location / drawing point. In case of discrepancy, Contract shall be terminated.
- 4. The supply of tanker water to offices/residential quarters at various locations within Chennai city limit preferably at the under mentioned facilities. However, the suppliers are required to deliver water at any facilities of SBI within Chennai city limit.
 - a) Underwoods Garden, RA Puram
 - b) Local Head Office, 16, College Lane, Nungambakkam.
 - c) Aparna Complex residential quarters, Nungambakkam.
 - d) SAF Games Village, Koyambedu.
 - e) Roshan Complex, Anna Nagar.
- 5. Applications without prescribed EMD & tender processing fees, non-submission of required details/information as per tender conditions shall summarily be rejected. Applications submitted by a firm shall be duly signed by the authorized person or Power of Attorney holder. Application by a company shall be executed by persons / duly authorized under the resolution of the Board of Directors of the Company.
- 6. EMD of the successful bidder(s) will be retained by the SBI till the validity of the tenure / contract **as a security deposit** for the work awarded and the same will refunded without any interest on closure / expiry of contract.
- 7. The duration of the contract for the above services would be for a period of twelve (12) months from the date of acceptance. However, contract may be renewed for a further period of one year on the same terms and conditions subject to satisfactory service rendered.
- 8. The supply of required quantity of fresh water at short notice is the essence of this contract. In case of any water shortage / any other constraints, the supplier shall make necessary alternate arrangements ensuring uninterrupted service.
- 9. The acknowledgement of trips shall be signed duly by the contractor and hand over to departmental pump operators / security at receipt point located at various storage tanks. Original delivery Chelan shall be handed over to the departmental representative.





- 10. The Bill for water supply will be raised on fortnightly basis by the service provider with the Bank supported with delivery challans, statement of gate pass etc., and duly certified by authorized representative of Bank. Delivery challans without acknowledgement of Bank's representative shall not be considered for payment.
- 11. Total quoted rate shall be inclusive of all charges viz. water testing charges, GST, any other levies/taxes, loading, waiting & unloading etc., consumables viz. provision of fuel, insurance, maintenance, wages of drivers etc.
- 12. The rate quoted will be in force for a period of one year for whole quantity of water mentioned above without any change for any reason thereof. Escalation in prices citing shortage/scarcity/season/fuel price escalation/wage escalation etc. shall not be entertained during contract period.
- 13. Quotation is invited for supply of 24,000 L capacity tankers. However, suppliers may also be asked to supply 12,000 L tankers on pro-rata basis of L1 rate quoted for 24,000 L as & when demanded by the Bank.
- 14. Water shall have to be supplied on urgent basis on short notice say within three hours of receiving the telephonic order, as and when required.
- 15. The Courts in Chennai city alone shall have the jurisdiction in respect of any or all matters relating to or connected with the tender.
- 16. State Bank of India discourages the stipulation of any condition by the tenderers. The conditional tender will be liable to be rejected.
- 17. Final award of the contract for the above services will be subject to the approval of the Competent Authority in the Bank.
- 18. The specifications, duration of the work and the terms and conditions under which the contract is required to be performed and also the rights and obligations of the person/s whose tender is accepted shall be under an Agreement to be executed strictly in line with tender terms & conditions duly incorporating the contents of respective schedule. Applicants submitting the tender shall have read the same and is always deemed to have read and understood the same before submitting the tender. Cost of agreement shall be borne by the supplier.
- 19. The Bank reserves the right to terminate the contract without giving any notice and forfeit the security deposit during the validity of contract, if there is any breach of service / contract by the Service provider viz. failure/delay in supplying the required quantity of water on time, quantity lesser than specified/billed, poor quality of water delivered, unsatisfactory and/or non-complaint with terms & conditions of contact, instructions issued time to time, unacceptable behavior of driver/labours with Bank's representative etc.
- 20. Bank reserves the right to accept or reject or split any or all tenders without assigning any reasons thereof.
