 - 2. The Bank is having actual possession of the secured assets.

- 8. It shall be the responsibility of the interested bidders to inspect and satisfy themselves about the property before submission of the bid.
- 9. The e-Auction/bidding of above properties would be conducted exactly on the scheduled Date & Time as mentioned against each property by way of inter-se bidding amongst the bidders. The bidder shall improve their offer in multiple of the amount mentioned under the column "Bid Increment Amount" against each property.
