- a) All Tenderers are informed that, price bidding for the work will be through e-tendering method. The bill of quantity of tender i.e "Price Bid" is to be submitted online on etendering portal. Orders will be placed by the Bank Medical Officer (BMO) to those empanelled Chemists/Suppliers/Stockists, to the (Lowest) Bidder at their quoted rates monthwise or as and when required.
- b) The Tenderer is expected to examine all instructions, forms, terms and specifications in the tender documents. Failure to furnish all information required as per the Tender Document or submission of bids not substantially responsive to the Tender Documents in every respect will be at the Tenderer risk and shall result in rejection of the Tender.
- c) In case the date of submission of EMD, Price Bid is declared as a holiday, the respective date will be considered on the next working day at the same time. The bidder, who is the authorized representative and participating on behalf of supplier/chemist/stockiest, should have a valid digital signature certificate (DSC) for this tender. The validity of the DSC should be atleast 3 months.
- d) Empanelled Suppliers/Chemists/Stockists are required to quote for all the medicine as per the requisition placed (Tentative list of medicine) and also offer uniform discount rate in the RFQ/Tender. Medicine order will be placed monthly or as and when needed from the tentative list of medicine based on the need at Dispensary. In case of not quoting for three consecutive RFQs/Tenders, appropriate action would be initiated including depanelling from the empanelled list.
- e) In case of need the Bank reserves the right to split/divide its purchase orders among L1,L2 and L3 bidders in the ratio of 60:20:20 at L1 bidded rates.
- f) The Initial security deposit of the successful bidder shall be forfeited, if the supplier refuses to accept the order or fails to supply the medicine within the prescribed time.
- g) The empanelled suppliers should possess **VALID DIGITAL SIGNATURE** for participating in e-Tendering process.
- h) The State Bank of India reserves the right to reject any or all the applications without assigning any reason therefor and no correspondence would be entertained in this regard.
- i) The State Bank of India may at any time cancel this tendering process without assigning any reason.
- j) Empanelled Supplier/Stockist/Chemist who have not submitted the security deposit are not eligible to participate in the e-Tendering.
- k) The Empanelled Supplier/Stockist/Chemist has to submit declaration form (Annex I). Non submission will be treated as disqualified for the e-tendering process.
