(c) Name of Eligible Bidders will be identified by the State Bank of India, ARMB, Chennai to participate in online e-Auction on the portal (bankeauctions.com) (C1 India Pvt Ltd) who will provide User ID and Password after due verification of PAN of the Eligible Bidders.

(d) The successful bidders shall be required to submit the final prices, quoted during the e-Auctions as per the annexure after the completion of the e-Auction, duly signed and stamped as token of acceptance without any new condition other than those already agreed to before start of e-Auction.

(e) During e-Auction, if no bid is received within the specified time, State Bank of India at its discretion may decide to revise opening price/scrap the e-Auction process/proceed with conventional mode of tendering.

(f) The Bank/Service Provider for e-Auction shall not have any liability towards bidders for any interruption or delay in access to the site irrespective of the causes.

(g) The bidders are required to submit acceptance of the Terms and Conditions and modalities of e-Auction adopted by the Service Provider, before participating in the e-Auction.

(h) The bid once submitted by the bidder, cannot be cancelled/withdrawn and the bidders shall be bound to buy the property at the final bid price.
