2. The generator must have hour meter and the fuel cost reimbursement will be done according to running hours basis of DG set. The same must be checked and verified by the SBILD official for monthly payment. For calculating the cost of diesel, the last day of the month diesel price will be considered. In addition to that volt meter, ammeter, frequency meter, RPM meter and MCCB of suitable rating must be installed in DG sets.

3. The vendor will have to supply and lay suitable length, size & capacity of armoured aluminum cable for connection from generator to Bank's change over.

4. The generator should be placed in the premises of Bank as earmarked by the branch.

5. The EMD of the successful bidder will be kept as security deposit with the bank for the contract period.

6. The vendor has to maintain the power cut, duration of operation of generator set log sheet in a register and to be counter signed daily with the Branch Manager.
