- 3) Bidders to quote strictly as per the BOQ.
- 4) Failure to comply with above shall lead to disqualification of bidders.
- 5) The amount of AMC will be taken into account while evaluating the overall bid amount.
- 6) The price entered in section II shall include charges for Comprehensive Annual Maintenance Contract (AMC) including the cost of spares & consumables, excluding taxes etc. fixed for 10 years after expiry of the defects liability and free maintenance period of 01 year. GST shall be paid extra as per prevailing rates.
- 7) Evaluation of the financial bids shall be based on Grand Total Amount (Section I + Section II) quoted by the bidder.
