- 3 Supplier must prepare sample of Rack and carry out load test for carrying load of 300 kg UDL on each shelf. After written approval of Rack from Bank/Architect remaining Racks shall be made. No extra payment shall be made for preparing of sample.
- <sup>4</sup> Weigh Bridge receipts must be produced along with bills, Material shall be weighed in presences Bank's representative. For payment purpose, total weight will be obtained by multiplying quantity with unit weight derived by averaging minimum ten samples.
- <sup>5</sup> Powder coating shall be done by using Berger paint. Material as per company specifications Thickness of powder coating shall be 50 microns

- <sup>6</sup> Test Reports shall be provided to Bank from Reputed laboratory approved by Bank for Finished and Raw material used and powder coating.
- <sup>7</sup> Size, thickness, dimensions or design may change as per requirement. No extra payment shall be made for this.
- <sup>8</sup> Top shelf of Rack shall not have stiffners and hollow tube at egde
- <sup>9</sup> Base plate of 1.25mm thick CRC sheet shall be provided at base
