Subject: Disclosure of events or information as required under Regulation 30 (4) of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 – Notice of Two Days' Nationwide Bank Strike on 16th & 17th December, 2021 given by United Forum of Bank Unions (UFBU)

Pursuant to the applicable provisions of SEBI (LODR) Regulations, 2015 read with Schedule III Part B (6) of the Regulations, we inform that, we have been advised by the Indian Banks' Association (IBA) that United Forum of Bank Unions (UFBU) has served a Notice of Strike, informing that the members of the constituent Unions of UFBU viz. AIBEA, AIBOC, NCBE, AIBOA, BEFI, INBEF and INBOC propose to go on a nationwide Bank Strike on 16th & 17th December, 2021 in support of their demands.

We advise that while the Bank has made necessary arrangements to ensure normal functioning in its branches and offices on the days of Strike, it is likely that work in our Bank may be impacted by the Strike.

In terms of SEBI Circular No.: CIR/CFD/CMD/4/2015 dated 09.09.2015, we advise as under:

6.1 At the time of occurrence:

- a) expected quantum of loss/damage caused;
- b) whether loss/damage covered by insurance or not including amount;
- c) estimated impact on the production/operations in case of strikes/lock outs;
- d) factory/unit where the strike/lock out takes place including reasons for such strike.

Loss cannot be quantified now.

6.2 Regularly, till complete normalcy is restored:

- a) insurance amount claimed and realized by the listed entity for the loss/damage;
- b) the actual amount of damage caused due to the natural calamity or other force majeure events;
- c) details of steps taken to restore normalcy and the impact of the natural calamity/other force majeure events on production or service, financials of the entity.
