URGENT WORK: SUPPLY AND FIXING OF SPLIT ACs AT RACC BRANCH ROPAR (63442)

1. We forward herewith the short-term Tenders for supply and installation of **11** no. Split ACs at RACC branch Ropar under RBO-6 Ropar.
2. The Tenders should reach us on or before 12.30 P.M. on 06.11.2021 and will be opened on the same day at 02.30 P.M. in presence of those representatives of the firms who wish to participate in the opening of tender. Also, the work order will be issued to L-1 bidder on the same day.
3. The Tenders should be sent in sealed envelope in the manner as explained below to the undersigned and marked Tenders for "SUPPLY AND FIXING OF SPLIT ACs AT RACC BRANCH ROPAR".
4. Envelope-I consisting covering letter, terms and conditions, declaration in lieu of EMD/Bid Security. In case any of the information provided is incomplete and does not found to be satisfactory, the tenderers will not be eligible for participation in tender (Part II Price Bid).
5. Envelope-II shall contain price bid. **In case your firm qualifies the technical bid, Envelope-II submitted by you will be opened same day at 02.30 P.M.**
6. The address for tender submission is **"THE REGIONAL MANAGER, SBI, RBO-6 ROPAR, 1ST FLOOR, PLOT NO-89, SECTOR-68, MOHALI, PUNJAB- 160068"**
7. The tenders without declaration in lieu of EMD/Bid Security will be rejected.
8. The tender shall remain valid for a period of 90 days from the date of opening.

Tender Terms & Conditions

1. Tender is to be applied by OEM directly or through their authorized dealer/distributors of M/s Daikin, M/s Blue Star, M/s Toshiba, M/s Mitsubishi, M/s Carrier only. Bidders have to submit the authorization from OEM along with dealer/distributor certificate/license.
2. 95% payment shall be released within 15 days after satisfactory execution of the work and remaining 5% will be kept as retention money and the same can be released after completion of warranty period of 1 year.
3. **Work is to be completed on priority within 07 days from award of work date, otherwise a penalty @ 0.5% per day of the contract value will be applicable to the maximum of 5% of contract value.**
4. Bank reserves the right to reject any or all Tenders without assigning any reason.
5. The quantity of ACs can be decreased or increased as per bank's requirement and the L-1 bidder must have to execute the work at the L-1 quoted rates for varied quantity.
6. All tenders shall be accompanied with declaration in lieu of EMD/Bid security failing which tender will be rejected. No change in declaration will be permitted.
7. The quoted rates will be valid for three months and the L-1 bidder have to provide the same as per bank's requirement.
8. The tender shall be submitted in the double envelopes - Envelope-I consisting of terms & conditions and EMD declaration and Envelope-II price bid. Both envelopes should be super-scribed as "SUPPLY AND FIXING OF SPLIT ACs AT RACC BRANCH, ROPAR".
7. The work will be executed in the presence of bank staff or staff assigned by the bank.
8. **The rates of ACs include cost of ACs, installation cost, transportation cost, accessories required etc. No compromise will be done in quality of the work.**
9. Vendor to ensure that bank's property may not damage while executing the task. For any damage the repair/renovation cost will be borne by the vendor.
10. All the equipment/material required for installation of ACs will be arranged by the vendor.
11. The contractors are advised to visit the site before quoting the rates.
12. Arbitration Clause: Any dispute and difference of any kind whatsoever, arising out of or in connection with this RFP or carrying out of the services, shall be settled amicably, if however, the parties are not able to resolve any dispute or difference amicably, the same shall be referred for arbitration in accordance with the provisions of Arbitration & Conciliation Act 1996 and re-enactment(s) and or modification(s) thereof and of the rules framed there under. The place for the arbitration shall be Chandigarh. Any dispute arising, thereafter, will be subject to the jurisdiction of the Courts at Chandigarh only.
