State Bank of India a body Corporate incorporated under the State Bank of India Act 1955 having its Corporate Centre at State Bank Bhawan, Madame Cama Road, Mumbai, one of the Local Head Office at 1 Strand Road Kolkata-700001, herein after referred to as "the Bank", Premises & Estate Department, Local Head Office, Kolkata intends to empanel reputed, reliable and experienced contractors/ firms/ companies having sound financial background, required experience, technical expertise, adequate qualified technical/skilled personnel and who satisfy the Bank's specified qualification criteria to undertake supply, installation, commissioning and maintenance of existing installed security equipment of

- (1) Microprocessor-controlled Alarm System with integrated sensors, hereinafter referred to as "Integrated Electronic Alarm System" or "IEAS"
- (2) Electronic Time Lock hereinafter referred to as Time Lock

(3) (a)Biometric Access Control System hereinafter referred to as "BACS" and (b)integrated Access Control-attendance-time management system installed at LHO and

(4) CCTV surveillance system (OPEX model for new installations and existing systems on OPEX. All other systems which are on CAPEX will be on CAPEX model)

at various Branches and Offices of Kolkata Circle of the Bank covering State of West Bengal, Sikkim and Andaman & Nicobar Islands. We are looking for vendors who have high degree of expertise and experience in supply, installation, commissioning and maintenance of above equipment having wellestablished service centres. The vendors must have expertise to undertake Annual Maintenance Contract of existing and already installed systems in the various Branches irrespective of make of the equipment including upgradation, integration and extension. Only those firms / vendors who satisfy the eligibility criteria - as mentioned hereunder - need respond. BANK reserves its rights to accept/reject any/all tender without assigning any reasons whatsoever and no correspondence shall be entertained in this regard. Please note that the Bank will not make any correspondence with any of the applicant except with the firms who will be qualified in the technical evaluation for selection of vendor in this regard in future.

2. Empanelment of vendors for the purpose will be for a period of <u>three years</u>. However, the Bank reserves the right to extend / reduce this period without assigning reasons whatsoever. During this period, Bank shall reserve the right to cancel the panel of vendors or go in for a fresh empanelment or extend the validity period of empanelment at its discretion but not more than 05 years and it shall be binding upon all the vendors who get empanelled through this exercise.

3. Being selected as an empanelled vendor does not guarantee work. Allotment of work & payment terms would be decided by the designated committee at Administrative Offices. Applicants to note that no negotiation on this issue would be entertained at any level.

4. Bidders who have been de-listed/black-listed/debarred for any service/supply of any type of equipment by the Bank, Govt. of India Organisations / PSU / PSE / Govt. Depts./reputed Private Sector etc. or the firms/companies/vendors whose services have been found to be poor/unsatisfactory in the past or the vendor has abandoned the services on their own by disregarding the contract are **not eligible to apply.**

5.Bidders who have previously abandoned providing services to the Bank dishonouring the agreement without any reason compromising Bank security must not apply

5. If at any point of time it is found with that the security of the Bank is compromised due to the act of negligence/undue delay by the representative of vendor / vendor, failure to ensure 24 X7 functionality of the security equipment all the work orders issued to the vendor would be cancelled outrightly and the all the work pertaining to the default vendor will be allocated to other empanelled vendors and the Bank would not be liable for any loss to such erring vendors.

I. <u>ELIGIBILITY CRITERIA</u>

Interested vendors fulfilling the following criteria will be considered for empanelment for the said work: -

3. <u>Financial</u>.

3.1 Audited Annual Turnover - A total of minimum Rs. 15 Crores for CCTV ,5 crores each for Security Alarm system and Electronic Time Lock separately during last three years. For Biometric access control & time management system is 01 Crore.

3.2 The firm should be in profit in the last three consecutive years.

4. Work Experience.

4.1 The applicant should have minimum 5 years relevant experience in supply, installation, testing & commissioning including Maintenance of installed equipment irrespective of make of the equipment.,

4.2 The firm should be in the current empanelled list of minimum three Scheduled Commercial Banks of which at least one should be a Public Sector Bank with valid 1st party AMC for the equipment mentioned in the bid document and

(a) should have carried out minimum 100 Integrated Electronic Alarm System installations (consisting of 04 or more integrated sensors), 100-time lock installations and 100 CCTV installations in different locations during the last three years, with aggregate value of order being not less than Rs. 5 Crore.

(b) For Biometric Access control & time attendance 03 years' experience in Banks/Govt. entity/reputed private firm and out of that, three should be running projects. 50 Biometric Access Control system device installation and three running AMC projects. in Banks/Govt. entity/reputed private firm.

Note:- Those applying for Access Control, Attendance & Time Management system installed at LHO, includes installed softwares/hardwares i.e. access control devices, flap barriers, turnstile,ID cum access card printing etc.. Must have adequate technical expertise to operate, maintain data base management various report generation extension/upgradation, designing, processing and printing of Bank ID cum access smart RFID card. If at later stage it is found that the vendor does not have above capabilities, the empanelment would be outrightly terminated with cessation of security deposit/EMD money and the firm will be blacklisted.

4.3 Documentary proof should be provided in support of experience like order copy/contract copy and installation certificate/satisfactory performance certificate. Further, *performance certificate* from at least 03 scheduled commercial banks one out of that should be a public sector Bank should be furnished.

5. **<u>Registration Requirements and general</u>**.

5.1 The applicant(s) must be registered entity, Direct authorised dealer, original equipment manufacturer of the equipment, firm and have requisite expertise for Maintenance, supply, Installation, Commissioning of the new system of following equipment's: -

- i. INTEGRATED ELECTRONIC ALARM SYSTEM (SECURITY ALARM SYSTEM)
- ii. ELECTRONIC TIME LOCK
- iii BIOMETRIC ACCESS CONTROL & TIME MANAGEMENT

iv. CCTV SURVEILLANCE SYSTEM (OPEX for new installations CAPEX for AMC of existing system)

5.2 Must have valid PAN, TAN, CIN, GST and other necessary statutory registrations, licenses required as per the Central and state Government guidelines.

5.3. Compliance with prevailing labour laws, rules and regulations of the State and Central Governments is required (documentary proof supporting this must be furnished by the firm/ vendor).

5.4 The applicant(s) must produce necessary documents to establish the ownership of the factory / workshop / Service center, such as rental / lease agreement / ownership deed or other such documents in the name of the company / proprietor.

5.5 The applicant must have one established registered/Branch Office at Kolkata and service centres at various places in the State of West Bengal, Sikkim and Andaman & Nicobar i.e Kolkata, Burdwan, Bankura, Siliguri, Malda, Berhampur, Kharagpur, Port Blair & Gangtok, (proof of electricity bill/telephone bill/Corporation or municipal tax receipt, copy of trade license must be enclosed). However, for integrated biometric access control-attendance-time management installed at LHO, Kolkata, applicant's office and service centre at Kolkata would be required.

5.6 No erasures or alteration are permitted. Every page submitted must have companies seal and signed by the authorised person with mention of designation

5.7 Decision of the selection committee shall be final and binding to all. No representation will be entertained. The Bank has the discretion to revise the scope of work upward/downward as per its requirement.

5.8 Proposal received after time of submission without proposal fee or EMD or conditional application would be rejected.

5.9 The documents provided by the vendor are nonreturnable. The Bank holds no responsibility if application is lost or delayed in postal/ courier transit.

5.10 If Bank observes any misrepresentation of facts on any matter at any stage, Bank has the absolute right to reject the proposal and disqualify us from the selection process.

Authorization Letter.

6.1. The applicant should either be the OEM of the proposed system / subsidiary company of a manufacturer company for such system or an authorized supplier / channel partner of a manufacturer/ Service provider of the proposed systems/ Access control & attendance system.

6.2. The applicant, if not the OEM of the proposed system, should submit the **authorization letter** from the OEM (Original Equipment Manufacturer) whose products are proposed to be installed. The vendor shall have to stock sufficient equipment/spare parts at the differently located service centre.

6.3. If the applicant is authorized supplier of the equipment, he should have back-to-back agreement with each of the equipment Manufacturer, so that direct support for maintenance, spares and upgrades are available for at least 5 years. Agreement certificate from the OEM to this effect has to be provided by the applicant.

6.4. The Manufacturer of the equipment must have a sound and well documented Quality Framework. Applicant must submit a valid ISO certificate, UL or certificate from any statutory /authorised government organisation in support of such claim.

6.5. The Bank reserves the right to visit Applicant/Manufacturer/Stock facilities to ascertain the above facts on site.

6.6. For CCTV system component parts (Brand /Make offered):

- a) The OEMs should be profit make company and should have positive network in the previous financial statements.
- b) Proposed OEM for any technology should not have filed for bankruptcy and should be profitable for at least last three consecutive financial years.
- c) The OEM providing CCTV cameras and NVRs should have at least 500 employees in its payroll in India and operating in the business of manufacturing CCTV equipment's for more than 10 years.
- d) The OEMs should have installed minimum 10,000 IP cameras of 2 MP cameras in India during last three financial years.
- e) The MAC address of IP cameras must be registered in the quoted OEM brand.
- f) The OEMs should have all requisites certification of international repute to ensure security system is not compromised. It should be ISO certified for its manufacturing process and information security management system. The registration certificate wherein the nature of business of the OEM is mandatory.
- g) The OEMs should have presence in India for last 7 years with fully equipped centre.
- h) Applicants to provide necessary certificates from OEM as mentioned above and provide a certificate from authorised signatory of the OEM that the applicant would be authorised to stock sufficient number of CCTV components i.e., DVR, NVR and cameras as specified for at least 5 years to cater the Bank's requirement if empanelled and OEM would supply the same.

7. Service Support Office.

7.1 The applicant should have an established service centre with technical personnel in Kolkata, Burdwan, Bankura, Siliguri, Malda, Berhampur, Kharagpur, Port Blair & Gangtok,

7.2 Since the work warrants regular maintenance and prompt service in case of a failure, vendor(s) should have adequate spares and number of trained manpower at service centres.

7.3 The vendor(s) must have adequate number of technicians on their roll who have necessary experience and expertise of the work. From the perspective of providing 24 x 7 support, the applicants should be prepared to open additional support offices, as and when required, at new centres. Complete address contact details and Documentary evidence for the same needs to be provided.

7.4 The vendor(s) must have their own works/factory/service centre which may be inspected by the Bank's Officials and the factory should have a proper and visible production line with the stock of materials at various stages of completion during the inspection.

7.5 The technicians employed should be well trained in supply, installation, commissioning and maintenance activity of the equipment, a list of such technicians with contact details with individual competency certificate issued by the vendors have to be submitted for verification by the Bank if found necessary. The list of such details to be updated quarterly and submitted to concerned Zonal Security Officer of the Bank. As all technicians would be working in Branches it is to be ensured by the company that their integrity, character & antecedents are verified by the local police.

7.6 There should be one point contact for all needs of the Bank. One dedicated (24 X 7) mobile number and dedicated email ID with dedicated company representative must be assigned by the vendor. The contact details of the person and the telephone numbers in, or service focal point(s) should remain unchanged during the currency of vendor's relation with the Bank. In case of any change, the vendor should inform all the Bank functionaries 15 days in advance from the date of proposed change. All e-mails by the Bank Branch/offices to be replied by the vendor on the same day if received during morning hours and the next day morning if received at late hours. The defect in the equipment detected during AMC visit by technician or reported by the Bank Branches/offices to be resolved/repaired by 12 hours if in the KMDA areas, 24 hours outside KMDA areas including other places of state of west Bengal and Sikkim. Complaints in Port Blair area to be resolved by 12 hours for other islands.

8. **Product Literature.** Evaluation will be done based on the documents submitted along with the bid without any further reference to the applicant.

8.1 As a part of bid process, the applicant shall furnish documents establishing the applicant's ability to supply the material i.e. stock statement signed by Auditor and Certificate from supplier and manufacturer.

8.2 The applicant shall also submit documentary evidence in the form of literature, drawing & data on the product being offered.

8.3 The applicant also has to submit a small video (Not more than 02 minutes/ 10 MB) demonstration on operation, testing, trouble shooting and health check of the equipment during the display/demonstration of equipment.

9. All documents including the system/equipment already installed or going to be installed during the AMC period shall be the property of the Bank. In case the service of any vendor found to be unsatisfactory or compromise Security due to delay/ deficiency of service, the Bank has right to modify, relocate or servicing through any of the vendor as per Bank's requirement and for the security & safety of the Bank.

II. SELECTION PROCESS

The Bank will evaluate the applications received from interested vendors in response to this 10. advertisement based on mandatory pre-gualification conditions. Marks under each parameter will be awarded by the committee but will not be disclosed to the vendors. Minimum gualifying marks shall be marks obtained within 20% of the highest obtained marks. The bids of the vendors securing less than the aualifying marks will not be considered for further evaluation. For example, if the highest vendor score 90 marks, than the applicants scoring 72 marks and above will be considered for further process. Only those applicants who meet the criteria will be short listed. The eligibility criteria considered for empanelment will be mainly based, but not limited, to the experience of the firm regarding Supply, installation, testing, commissioning and maintenance of system/equipment within stipulated period, resources & stock of materials, skilled technical team with experience, proper service centre at different locations within West Bengal & Sikkim and A&N Islands, experience on similar work in banking sector, financial health, other mandatory documents etc. A copy of mandatory Pre-Qualification Requirements is enclosed at Annexure-I. Each firm will fill up the same and submit Annexure I. Annexure II. Annexure III. related documents, a non-refundable demand draft of Rs. 5000/- in favour of State Bank Of India, payable at Kolkata along with EOI & RFP separately for each Security equipment. The annexure will be signed by authorised signatory of the firm and stamped with the Company's seal. The comments of the firm should be supported by copies of relevant documents. Agency having service centre or presence in Andaman & Nicobar Island would be given preference & considered for empanelment exclusively for Andaman & Nicobar Islands.

Note: If the applicant intends to apply for more than one category, they should pay applicable application fee separately for each equipment and submit expression of interest & RFP separately for each category in separate envelopes with proper superscription on top

11. Application Procedure.

11.1 All eligible applicants to submit EOI and RFP application (two separate envelopes in a large envelope)..Only physical applications to be submitted in the Tender Drop Box kept at 9th floor, B-Block Premises & Estate Dept. Samriddhi Bhawan along with processing fees by means of Demand Draft in favour of State Bank of India, payable at Kolkata.

11.2 Only shortlisted applicants will be communicated by letter/e-mail. No other communications will be entertained.

11.3 All shortlisted applicants would submit BOQ/Price bid along with EMD/Security deposit in favour of State Bank of India, payable at Kolkata separately for each security equipment by means of Demand Draft.

12. Date of Technical demonstration of the equipment by the applicants (not OEM) would be intimated to the shortlisted applicants before the price bid by email/telephone.

13. The vendors who submit all RFP documents along with Technical and Price bids as mentioned in RFP will be advised to make a live demonstration at Samriddhi bhavan, CSO Department/Premises & Estate Department, State Bank of India, Local Head Office, 1, Strand Road, Kolkata – 700001. The demonstration should focus on technical specifications of offered products and firm's capabilities to provide maintenance services & its proposed methodology for execution of this project. During demonstrations, the vendors must show all the features exactly as per description in their technical bids. Comparative evaluation of technical bids will be done by a committee only after all the demonstrations by all the interested vendors are completed. Thereafter, the representatives of the Bank may visit their factory/workshop for checking infrastructure of the vendor(s). All vendors whose products are finally approved will be considered for taking part in price bidding process. Notwithstanding any thing contained above the Bank reserves the right to alter any of the conditions or statement above in the RFP

14. The **'Price Bid'** of only those vendors will be opened who qualify in the process mentioned at Section 13. The lowest rate for each item offered by any of these vendors will be offered to all other vendors for their acceptance and will be termed as **'Approved Rates'**. All vendors who accept the approved rates would be considered for empanelment. However, the Bank is not bound to accept the lowest tender and reserves the right to accept either in full or in part of any tender.

15. The leading interested vendors for each equipment, who qualify in the above process, will be empanelled by the Bank. **Each participant must apply separately for each equipment**.

16. The Bank reserves the right to reject any or all applications without showing any reason whatsoever. In the event of such rejection of application, the EMD/ Security deposit will be released without any interest. For successful bidders, the amount will be retained in the form of security deposit for the entire period of empanelment, unless forfeited and will be released without interest on cessation of empanelment.

17. The Bank may conduct any exercise to check the capability of the participants technical proficiency. The cost of such exercise/testing to be borne by the participants.

18. Sub-contracting or engaging third party vendors is not permitted.

19. Relaxation in any of the terms contained in the Bid is not permitted.

14.4 The Empanelment application shall be typed or written in indelible ink and shall be signed and stamped by the Manufacturer/ Firm/ Company/ Dealer/ Vendor or a person or persons duly authorized to bind the Manufacturer/ Firm/ Company/ Dealer/ Vendor to the Contract. The name and designation of the person or persons signing the Bids with their signature on last page and signature/ initials and stamp should be put on all pages of the Bids, except for un-amended printed literature.

14.5 Any inter-lineation's, erasures or overwriting shall be considered as invalid application. The Bank reserves the right to reject applications not conforming to the above.

14.6 If the envelope is not properly sealed and marked, the application will be rejected.

15. SUBMISSION OF APPLICATIONS

15.1 Applications must be submitted at the address specified, not later than the date & time specified in the RFP.

15.2 In the event of the specified date for submission of applications being declared a holiday for the Bank, the empanelment documents will be received up to the appointed time on the next working day.

15.3 The Bank may, at its discretion, extend the deadline for submission of applications by amending the empanelment documents, in which case, all rights and obligations of the Bank and Manufacturer/ Firm/ Company/ Dealer/ Vendor previously subject to the deadline will thereafter be subject to the extended deadline.

16. <u>LATE APPLICATIONS</u>: Any application received after the deadline for submission of applications prescribed, will be rejected and returned unopened to the Manufacturer/ Firm/ Company/ Dealer/ Vendor. SBI is not responsible for courier/ postal/air delays.

17.PRELIMINARY EXAMINATION

17.1 The Bank will examine the applications to determine whether they are complete, required formats have been furnished, the documents have been properly signed, and the empanelment documents are in order.

17.2 Prior to the detailed evaluation, the Bank will determine the responsiveness of each application to the Empanelment Process. For purposes of these Clauses, a responsive application is one, which conforms to all the terms and conditions of the RFP without any deviations.

17.3 The Bank's determination of an applicants' responsiveness will be based on the contents of the application itself, without recourse to extrinsic evidence.

17.4 If an applicant is not responsive, it will be rejected by the Bank .

18.TECHNICAL EVALUATION

18.1 Only those Manufacturer/ Firm/ Company/ Dealer/ Vendors and Applicants who have been found to be in conformity of the eligibility terms and conditions during the preliminary evaluation would be taken up by the Bank for further detailed evaluation. Those applicants who do not qualify the eligibility criteria and all terms during preliminary examination will not be taken up for further evaluation.

18.2 The Bank reserves the right to evaluate the applications on technical & functional parameters including factory visit and witness demonstration of the system and verify functionalities, response times, etc.

18.3. Bank reserves the right to verify the photocopies of documents submitted by the applicants with the originals.

18.4. Bank will evaluate the technical and functional specification of all the equipment quoted by the Manufacturer/ Firm/ Company/ Dealer/ Vendor for various criteria stipulated in the RFP.

18.5 TECHNICAL BID: Technical bid will be evaluated by the designated committee of the Bank according to its requirement for ensuring security & safety of its Branches & offices and take necessary decision on empanelment.

18.6 The decision of the Committee will be final and binding on the participants.

19. EMPANELMENT OF THE VENDORS:

19.1 Those Manufacturer/ Firm/ Company/ Dealer/ Vendors who qualify in prequalification, technical evaluation and Price bid/E-bid will be eligible for empanelment in the Bank for period of 03 years. The validity of empanelment may be renewed at the discretion of the Bank on the existing terms and conditions for not exceeding five years, provided that the vendor performance is found to be satisfactory during the Contract period. That until a formal contract is prepared and executed, this offer, together with the Bank's written acceptance thereof and the Bank's notification of award shall constitute a binding contract between Bank and successful Manufacturer/ Firm/ Company/ Dealer/ Vendor.

19.2 The performance of the Manufacturer/ Firm/ Company/ Dealer/ Vendors will be reviewed on yearly basis. The Manufacturer/ Firm/ Company/ Dealer/ vendors have to submit their consent in writing for working with bank as per the Terms and Conditions of this RFP on their company letter head, signed and affixed with seal by the authorized person (Form – I).

19.3 Review of the performance of the empaneled vendor will be done on yearly basis.

19.4 EMD / SECURITY MONEY DEPOSIT: EMD/ Security Money Deposit should be submitted by the Applicants as mentioned in the RFP

19.5 During the process of empanelment if any applicant found to be indulged in price manipulation or quoted unreasonably underpricing than the market rate /rate by OEM, such application will be outrightly rejected.

19.6 The lowest one (L1) rate quoted by the applicants for separate equipment, component parts, AMC service charge etc. would be considered as Bank approved rates for all purposes. 20.GENERAL

20.1 The Manufacturer/ Firm/ Company/ Dealer/ Vendor shall present a comprehensive description of the architecture and configuration of the proposed system, identifying salient features and functions that include design proposal with layouts, diagram, etc.

20.2 Any functions or features not specifically mentioned in technical specification of the product, but which may be necessary for the completeness and efficient performance of the system as an operating entity shall be indicated by the Manufacturer/ Firm/ Company/ Dealer.

20.3 The Manufacturer/ Firm/ Company/ Dealer/ Vendor shall clearly indicate the country of origin, manufacturer of the equipment

20.4 All systems and components must be in compliance with certifications as mentioned in the respective specifications.

20.5 The bank may arrange for the OEM/ third party inspection of the products/equipment provided (as per the RFP document) for the system installed for its meeting the entire RFP criterion. The Manufacturer/ Firm/ Company/ Dealer/ Vendor who wins contract shall provide all the possible assistance in this process. In case it is found that the equipment/hardware/ software supplied is not as per given brands / specifications, SBI will take a suitable action as deemed fit.

20.6 It will be imperative on each of the vendors to fully acquaint themselves with all the local conditions and factors, which can have any effect on the performance of the contract.

20.7 Earthing arrangements and electrical safety for all the equipment shall be the responsibility of the Supplier and to be carried out as per standard procedures.

20.8 The system software should be free of cost along with the system price and in future if any up gradation is required for running of the system than it should be upgraded free of cost.

20.9 The existing CCTV system installed under CAPEX model only will be on AMC. new installations will be on OPEX model only. The existing installed systems under OPEX structure will be awarded to the original installer of the system if selected in the bid along with the new rate, terms & condition. If any of the existing vendor not selected, the items will be returned to the vendor.

20.10 Vendor should carry out AMC/ installations tasks in close coordination with the Branch Manager, responsible persons at AO/RBO and Zonal Security Officer, depending on the Bank's requirement.

20.11 The Company shall not subcontract. Any contravention of such clause by the

company will automatically treat this contract as terminated and the company will be

liable to compensate the Bank for any loss/damages caused due to such unauthorized subcontract/assignment by the company.

20.12 The Bank reserves the right to get the system checked/ serviced/ repaired by any

other Company in case the Company awarded with the AMC does not attend the complaint within the stipulated time given above along with initiation of penal action for the delay/negligence by the company. The cost of such services taken from other company will be recovered from the defaulting company.

20.13 No deviation is permitted from the specifications of the security/surveillance equipment as mentioned in the annexures of RFP.

20.14 Being selected as an empaneled vendor does not guarantee work. Allotment of work & payment terms would be decided by the designated committee at Administrative Offices. Applicants to note that no negotiation on this issue would be entertained at any level.

20.15 The Bank would have right to change the specifications and technology if any change in the central policy of the Bank is affected and the vendor would be liable to adopt those changes.

21. BANK'S RIGHT TO ACCEPT ANY APPLICATION AND TO REJECT ANY OR ALL APPLICATIONS: The Bank reserves the right to accept or reject any Application in part or in full or to cancel the Empanelment Process and reject all Applications at any time prior to contract without assigning any reason.

22. TECHNICAL SPECIFICATIONS OF SECURITY AND EQUIPMENT: All necessary hardware and software required to make the security system will be strictly as per technical specifications given for each of the equipment (Refer Appendix-5 for specification/ qualification). The specifications given are as per minimum requirement. Vendors can quote equivalent or higher technical specifications to meet the Bank's requirements. However, no weightage would be given for higher configurations.

23. TERMS AND CONDITIONS OF CONTRACT:

23.1During the terms of this agreement the company /service provider agrees to maintain the already installed equipment and its accessories/ integrated parts irrespective of make and brand in fully functional and good conditions. In case of new installations install the Bank approved equipment within stipulated period and provide warranty as applicable. The old wiring, cabling to be removed if new cabling is required.

- (a) It will be mandatory for the Company to provide mandatory quarterly preventive visit by qualified service technicians and corrective visit at any number of call-in cases the equipment or any of its integrated parts malfunctions. However, monthly visit to currency chest to be carried out.
- (b) The service engineers should possess adequate know how, spare parts during their visits so that replacement repair is done without delay and compromising security. In case repair is not possible on the same day a standby equipment has to be installed without any deviations.
- (c) The preventive visit should include testing the functioning of equipment as desired along with all the integrated parts, cabling and trigger points. It also includes necessary cleaning & repairing, replacing worn out or defective parts with new Bank approved parts. The service technician should also invariably impart training to the Branch officials on normal operations, troubleshooting etc.
- (d) Details of each visit/call/repair undertaken etc. to be entered in the Security register. The details should include No of equipment systems, No of integrated parts installed with location in the Branch, details of defect, date of defect detected and date time of repair and becoming full functional.
- (e) Apart from the entry in security register service report as per the Bank approved format for each visit/call to be raised which should be signed by the Branch Manager /authorized official as an acknowledgement of the work done

satisfactorily. A summary of monthly progress report of AMC to be submitted to the concerned Zonal Security Officer. A monthly report for all the currency chests under the module to be submitted to the Zonal security officers as per the Bank approved format.

- (f) Within the period of contract SBI shall have the right to shift the system to an alternate site/within the branch and installed thereat. In event of shifting/renovation of branches, removal of system immediately before the shifting/ renovation and re-installation within 48 hours is to be done. SBI shall bear the charges for such shifting and reinstallation on actual basis
- (g) The Company shall issue <u>Photo-Identity Cards</u> to all its employees who would be deployed for the maintenance or any other work for the System. The <u>Photo-Identity Cards</u> shall be signed by the employee concerned and the authorized signatory of the Company. The employee should essentially carry, while visiting the branches, their photo identity card and copy of work order issued to the company.
- (h) During the undertaking maintenance work special care to be taken by the technicians that other systems, materials in the branch are not disturbed or damaged. The technicians should coordinate with other workers contractors engaged in the premises so that no work is affected, and disadvantage caused to the Branch
- (i) Technicians should follow all the security and safety guidelines as per the industry standard. Bank shall not be held responsible for any injury or accidental loss caused to the technicians or materials of the company.
- (j) Technicians while working should ensure that all the security equipment are connected to UPS supply.
- (k) In case if the book value of the equipment has become "Zero" and is

nonfunctional, then the said equipment will be bought back by the company at

a cost mutually agreed between the Bank and the Company and a NEW

equipment as approved by the Bank will be installed at the branch by the

Company only after specific recommendation of Zonal Security Officers.

- (I) There should be one point contact for all needs of the Bank. One dedicated (24 X 7) mobile number and dedicated email ID with dedicated company representative must be assigned by the vendor. The contact details of the person and the telephone numbers in, or service focal point(s) should remain unchanged during the currency of vendor's relation with the Bank. In case of any change, the vendor should inform all the Bank functionaries 15 days in advance from the date of proposed change. All e-mails by the Bank Branch/offices to be replied by the vendor on the same day if received during morning hours and the next day morning if received at late hours. The defect in the equipment detected during AMC visit by technician or reported by the Bank Branches/offices to be resolved/repaired by 12 hours if in the KMDA areas, 24 hours outside KMDA areas including other places of state of west Bengal and Sikkim. Complaints in Port Blair area to be resolved by 12 hours and by 48 hours for other islands.
- (m)The company should be responsible to maintain all the security/ surveillance equipment fully functional all the time and in case of failure of the system at any point of time, appropriate penal action will be taken by the Bank including police complaint/legal proceedings/financial penalty and recovery of the losses incurred by the Bank due to such failure.

- (n) Except the approved CAPEX cost /AMC Charges and rental value in case of OPEX and applicable taxes no other payment shall be made by the Bank . The scales of charges/rental payable by THE BANK to THE COMPANY shall not be reviewed during the currency / validity of the contract.
- (o) The company shall also ensure that there shall not be more than three failures of critical component of security equipment in a calendar quarter. The deviation of this would be treated as deficiency of service .This would also raise question on the technical competence of the company .
- (p) COMPANY shall, during the term of this contract, enter into arrangements with any of its customers providing greater benefits or more favourable rates & terms, the contract shall thereupon be deemed to have been amended to provide the same and similar benefits and favourable rates/ terms to THE BANK. THE COMPANY shall be answerable to THE BANK for any concealment / suppression of information causing loss to THE BANK and shall compensate the bank accordingly.
- (q) In case the approved model is not available in the market (Certificate from manufacturer/Distributor regarding non availability & quality) Then a better quality/higher version equipment compatible to the system may be installed without any cost to the Bank and with the due permission from concerned Security Officer.

(r) <u>Clauses for CCTV (In addition to other clauses in the RFP):</u>

(i)The CCTV systems which are installed on CAPEX and already under AMC would be covered under AMC Contract. Replacement of old and obsolete CCTV systems would be recommended by Zonal Security officer if the systems are more than 05 yrs old and became non reliable (frequent mal functions reported by the Branch).

(ii) All new CCTV systems if required and recommended by the Zonal Security officer should be installed (NVR with IR Cameras) on OPEX structure only and as per the approved models and rates except CABLE (including consumables required for cabling) which shall be installed on CAPEX structure. No AMC Charges will be applicable for installation under OPEX Model. Only Monthly rentals will be paid on quarterly basis.

(ii) Wherever possible the existing cabling if any to be used. If the cabling is done under OPEX structure the cost of the cabling will be paid by the Bank and the cable will be the property of the Bank. All other equipment i.e Cameras, NVRs/DVRs, Hard Disc Drives, Monitors, Microphone, Speakers etc will be property of the service provider. However the cables should be properly maintained during the contract period and will be returned to the Bank at termination of contract in same order & condition. The company shall be responsible for any unfair wear & tear due to non-maintenance b and shall be liable to replace the cable without any additional cost to the Bank. Quarterly preventive maintenance visit is mandatory during the contract period.

(iii) In case of termination of the contract by the Bank, all the equipment under OPEX structure will be removed and taken by the company without any cost to the Bank. The Hard disc drive may be retained by the Bank for which charges to be paid by the Bank as, within first 12 months after installation 80 %, 12 to 24 months 60 % and 24 to 36 months after installation 30 % of the CAPEX value. Beyond 36 months after installation: Nil. (iv) The company will be fully responsible to maintain storage and to retrieve data from the system and hand over the same to Bank's designated official as and when required as per the following: Minimum 180 days back up covering the entire premises with 2 MP resolution and 25 FPS.

(v) If more than three failures in a calendar quarter is reported from any Bank premises the company shall replace the defective equipment with new compatible equipment, acceptable to the Bank immediately.

(vi) The company shall arrange to adopt all measures to ensure the CCTV system installed In OPEX structure against loss or damage by fire, theft or other risks etc. Bank will not be responsible for such loss or damage of the items on rental. No additional cost on account of insurance shall be paid by the Bank.

(vii) All precautions against flood, earthquake, Land slide, Lightening etc to be adopted by the company to protect the installed equipment. In case of damage of any equipment installed under OPEX structure, immediate repair/replacement to be made by the service provider without any cost to the Bank.

(viii) Backup data quality and 180 days backup will be the responsibility of the vendor.

(ix) The system installed under OPEX model would invariably to be replaced after 05 yrs of installation with new system if the same vendor is allotted the work without any cost to the Bank.

(s) <u>Clauses for Access Control & Time management installed at LHO (In</u> addition to other clauses in the RFP):

(i) During the currency of Comprehensive AMC, The Company shall undertake Preventive Maintenance of entire already installed and functional system including flap barriers, database, card readers and associated services with the existing integration with installed face recognition device. Repair/ rectification of any defect/ fault in flap barriers, tripod, Card readers, magnetic locks installed at various places in LHO premises, system software, database, card readers, biometric readers and associated components. Database preparation/ updating / amendment and database validation. Printing of ID-cum-attendance/ access cards of the Bank employees. Enrolment of smart cards in database. Integration of all devices in same network. Report generation on all working days and as and when required by the Bank. Other services associated with Access Control system, time management and software supplied by the Company.

(ii) Provide services of onsite manpower support. Undertake upgradation, extension of the existing system as per the requirement of the Bank.

(iii) The company shall supply necessary spare parts accessories free software available with the devices for maintenance/repair as mentioned in the concerned Annexure without any cost to the Bank. If THE COMPANY is required to replace consumables or any other parts not mentioned in Annexure, THE BANK will reimburse to THE COMPANY cost of such replaced consumables or spare parts against production of bills of purchase provided and the cost quoted in the bill matches with existing

approved rates or by competitive quotation and if prior permission of THE BANK is taken before undertaking such replacement.

(iv) For the items not included in AMC & required for further extension /upgradation will be paid by the Bank on actual basis or as per the approved rate.

24. Performance guarantee money needs to be deposited separately for each equipment by the company in the form of demand draft/Banker's Cheque /fixed deposit to the Concerned RBOs /AOs/LHO form where the work order is issued. Performance Guarantee Money shall be calculated as : Cost of AMC X Number of Branches = "A", 15 % of A will be the performance guarantee money. , which will be returned without interest after expiry of contact period.

25. Any changes to the existing approved system shall not be made without prior permission of the Bank. However, if the Bank desires to shift the equipment to a new site/renovate the existing site and install it thereat urgently. The Bank shall, subject to approved rate of this Agreement, bear the charges for such shifting/renovation and reinstallation.

- 25.1 The company service technician to inform his visit timing to the Branch Manager / designated officer of the Bank premises before visit. All the works to be done during working hours only or as per the convenience of the Branch with prior permission of the Branch Manager.
- 25.2 The Company acknowledges that all material and information which has or will come into its possession or knowledge in connection with this Agreement or the performance thereof, consists of sensitive, confidential or proprietary data whose disclosure to or use by third parties will be damaging or cause loss to the Bank. The Company agrees to hold such material or information in strictest confidence and not make use thereof other than the performance of this Agreement. The Company agrees to take full responsibility with respect to its employees to ensure that the obligations of 'non-use' and 'non-disclosure' of confidential information under the agreement can be fully satisfied. The Bank reserves the right to proceed against the company & its officials / technician for non-observance and/or failure to observe secrecy / confidentiality at appropriate forum including court etc.
- 25.3 The Company confirms and warrants that the repair and maintenance service/products hereby sold do not violate or infringe upon any patent, copyright, trade secret, or other property right of any other person or other entity. The Company agrees that it will, and hereby does indemnify/defend the Bank from any claim directly resulting from or arising out of any proven breach of this warranty at its own cost & expenses in any proceeding or otherwise against The Bank.
- 25.4 All the statutory and regulatory obligations matter pertaining to licence, permit, labour law etc. will have to be complied by the Company and the Bank will not be responsible in case of any default. Company/Firm shall indemnify the Bank from all claims relating to the worker/staff wage, overtime, leave, provident fund, ESI, medical facility, gratuity, bonus etc. or any other claim as applicable and stipulated in any statutory provision rules or order of competent authority.

26 **PENALTY**:

26.1 Any complaint/ Service call made by telephone call, Mobile call, email, letters, work orders by the Bank officials to be resolved/repaired by 12 hours if in the KMDA areas, 24 hours outside KMDA areas including other places of state of west Bengal and Sikkim. Complaints in Port Blair area to be resolved by 12 hours and by 48 hours for other islands. Failing which a penalty of Rs. 200 per day shall be deducted from AMC charges payable to the company or by any mode, which includes from any payment to be made by the Bank to the company, Security deposit, performance guarantee money. In case of equipment under OPEX Rs. 200 per day will be deducted from the rental value in addition to forfeiture of rent of the non-functional days. In case of any eventuality if the bank suffers loss and it is revealed that the security equipment did not function,

appropriate legal action will be initiated including recovery of the lost amount from the company. **However**, this penalty shall not apply in case of delays in restoration of system caused by so called acts of God, War, Earthquake, Tsunamis, Riots, Bandhs, Civil Disturbances, Declared Pandemic conditions by government or any of which affect either the vendor's nearest service center or the site of installation. The decision of imposition of any penalty by Bank shall be binding, conclusive and non-objectionable on the part of empaneled agency.

- 26.2 In the event of the company abandoned the services to the Bank dishonoring the agreement / cease to conduct business, the Bank shall forfeit all its dues including Security deposit and performance guarantee money. In addition, the Company will not be allowed to participate any future tendering processes of the Bank.
- 26.3 . In case of absence of onsite manpower provided at the LHO for Access control and time management, One day salary plus penal Charges @ Rs. 750.00 per day shall be deducted from the charges payable to the company or from the security deposit along with other actions as deemed fit by the Bank.
- 26.4 If any employee/ technician of the company found to be indulging in any corrupt practices, improper behavior with the Bank officials, customer in the Bank premises causing loss of reputation /revenue of the Bank, the Bank shall be entitled to terminate the contract forthwith duly forfeiting all the dues of the company.

26.5 If the company for CCTV fails to maintain adequate storage of CCTV footage in terms of quality & quantity /fails to provide CCTV footage in the event of any incident or requirement of the Bank, penalties as under per instance per site will be charged: (i) For Backup less than specified days- Rs.200/- per day plus loss caused to the Bank on account of penalty by Govt. & any authorized agency, (ii) For resolution less than 2 MP-Rs. 10000/- (iii) For less than 25 FPS- Rs. 10000/-. In addition, the loss incurred to the Bank for such irregularity by means of regulatory penalty or incidental loss/damage shall be recovered from the dues of the company.

- 26.6 Not maintaining service centers as specified in the RFP , Rs 1000 per center every instance.
- 26.7 It is the responsibility of the vendor to know the Bank guidelines regarding CCTV coverage/footage/backup and in any case if the Bank is penalized by any regulatory authority due to the lack of above parameters due to the negligence/delay by the vendor, total penal amount would be recovered from the vendor dues from Bank/Security deposit/EMD and the Bank will have the discretion to terminate the contract.

27. FORCE MAJEURE :

27.1 Notwithstanding the above provisions, the Company shall not be liable to penalty or termination for default if and to the extent that its delay in performance or the other failure to perform its obligations under the contract is the result of an event of the Force Majeure. For purposes of this clause," force majeure" means an event beyond the control of the Company and not involving the Company's fault or negligence and not foreseeable. Such events may include but not restricted to war or revolution and epidemics. If a force majeure situation arises, the Company shall promptly notify the Bank in writing of such condition and the cause thereof. Unless otherwise directed by the bank in writing, the Company shall continue to perform its obligation under the contract as far as is reasonably practical and shall seek all reasonable alternative means of performance not prevented by the force majeure event.

27.2 Under OPEX (Rental)structure and for the equipment under warranty, Bank will not be liable to pay for or compensate the company for any damages caused to its equipment due to acts of God.

28 PLACING OF WORK ORDER, BILLING & PAYMENT:

28.1 The workorders for security equipment shall be placed by the Branch Manager/ RBO officials after taking the opinion of the Zonal Security officer or as per the advice of Zonal Security officer. ZO/RBO may construct their own rule of operation on the subject.

28.2 The Bank will pay properly submitted valid invoices within reasonable period. All the bills should have printed Account Number, Bank details with IFSC & MICR Code. All bills to have printed GST number of both the company and the Bank. Company should have SBI Account Number.

28.3 The Bills must have the details of items with their **Brand**, **Model Manufacturing unique Serial Number separate for each item**. The bills also to include location of the installed items in clear terms mentioning Branch Name, Address, Floor, Sub office Name if any, Branch Code, date of service & installation, period of AMC/ Rental etc.

28.4 "AMC Charges"/ "Rental Charges means" the price payable to the Vendor under the Agreement as per Bank approved rate.

At the end of every four months, Service Reports as per the Bank advised format duly signed by the Branch Manager/authorized/designated officer of the Bank premises along with the bills/invoice and copy of work order have to be submitted by the Company to the respective Regional Business Offices (RBOs) for payments. ZO/RBO may construct their own rule of operation on the subject.

29. SECURITY DEPOSIT: a Security deposit for each equipment separately in the form of Demand Draft/ Banker's Cheque favouring State Bank of India payable at Kolkata needs to be submitted at Local Head Office Kolkata for entire contract period as mentioned in the Table of Para 4 column No. 7. The same will be returned to all unsuccessful bidder without any interest. For successful bidders the amount will be retained in the form of security deposit for the entire period of empanelment unless forfeited and will be released without interest on cessation of empanelment.

28 **RESOLUTION AND DISPUTE**:

All disputes and differences in connection with or relating to this contract shall be subject to jurisdiction of courts at Kolkata.
