## Brief Profile of Smt. Saloni Narayan

Smt. Saloni Narayan, Deputy Managing Director, State Bank of India, joined the Bank as a Probationary Officer in the year 1988 and has been appointed as Deputy Managing Director (Finance) on 07<sup>th</sup> June, 2022. Prior to this, she has handled the portfolio of Deputy Managing Director (Retail Business) and Deputy Managing Director (Chief Operating Officer).

She was looking after the various Business Units in Retail & Digital Banking Vertical, such as Personal Banking, Real Estate & Housing, SME and Wealth Management. She also oversaw the functioning of Credit Monitoring and Customer Value Enhancement Departments. In the earlier assignment as DMD (COO), in addition to the above areas, she handled Operations Department in Retail & Digital Banking Vertical.

As Deputy Managing Director (Retail Business), Smt. Narayan led all businesses related to individual, namely Personal Banking, Real Estate & Housing and Wealth Management. She was responsible for driving business not only through the traditional branch channel, but also through digital channels and has been expanding business through multiple journeys on the Bank's mobile app - YONO.
