Condition:

- 1) The rate quoted by the bidders is expected to be match with the estimated cost.
- 2) Bidders should furnish the EMD along with their bids. The EMD amount will be forfeited if the tendered unilaterally withdraw, amend, impair or derogate from his offer in any respect within the period of validity of his offer. The applicant having registration with MSME is exempted from submitting the EMD amount subject to submission of relevant MSME registration certificate. (relevant copy to be enclosed), without submission Price Bid will not be opened.
- 3) The highest accepted bidder should deposit the quoted amount (less quantity which are not available) within 24 hours positively by 21.09.2023.
- 4) Late Bids i.e bids received after the specified date and time of receipt will not be considered.
- 5) If the price offered by the highest bidder is not acceptable than Bank's estimated cost, a negotiation may be held only with the highest bidder. If the highest bidder(H1) deny to do the disposal work, than H2 bidder will be offered to dispose the material at the price offered by the H1 bidder.
- 6) In case the selected bidder does not show interest in depositing the balance sale value or in lifting the goods, the bid security will be forfeited.
- 7) In case the total quantity to be disposed cannot be taken up by the highest acceptable bidder, the remaining quantity may be offered to the next higher bidder at the price offered by the highest acceptable bidder.
- 8) The bidders who are not qualified in the technical bid, the price bid envelope of the same bidder will not be opened.

Letter of undertaking

<u>Disposal of scrap (OBSOLETE AND UNSERVICIABLE ITEMS (Miscellaneous items) from CSD building,</u> New Guwahati.

With reference to the tender for the above work, we hereby undertake –

- 1. That we have fully understood the scope of the work to be carried out and acquainted ourselves to the local working conditions.
- 2. That our quoted rate is inclusive of all the material cost, labour cost, transportation, loading & unloading, freight, overhead and profit and Bank shall not entertain any claim whatsoever on this account afterwards.
- 3. That after accepting the work order we shall not back out, failing which the Bank shall be at liberty to forfeit the ISD and take action against us as deemed fit without making further reference to us.
- 4. In case of failure to complete the work entrusted to me on time i.e. 2 days under normal circumstance, Bank has the right to cancel the work order at any time without assigning any reason thereof and the materials present in the branch premises will be the property of the Bank. Bank then may complete the pending work by engaging the services of other contractor and the cost of such work will be deducted from my bill.
- 5. That we shall complete the work within the stipulated time and we understand that in case of delay on our part is liable to forfeit the EMD amount and the quoted amount deposited will not be refunded.
- 6. That we shall attend to any defect in the work done by us which is brought to our notice within the defect liability period, at our cost and shall not claim any extra cost for the same, failing which the Bank shall be at liberty to forfeit the Security deposit without making any further reference to us.
- 7. That we shall adhere to all the safety measures as per stipulations made by the competent authority.
