


#### 14 Other conditions

- a) Bidders shall hold a valid digital Signature Certificate issued by competent authority and valid email ID (e-mail ID is absolutely necessary for the intending bidder as all the relevant information and allotment of ID and Password by M/s MSTC Limited may be conveyed through email).
- (b) Names of Eligible Bidders will be identified by the State Bank of India, Stressed Assets Management Branch (SAMB) Ahmedabad Branch to participate in online e-Auction on the portal <a href="https://www.mstcecommerce.com/auctionhome/ibapi/index.jsp">https://www.mstcecommerce.com/auctionhome/ibapi/index.jsp</a>. M/s MSTC Limited will\_provide User ID and Password after due verification of PAN of the Eligible Bidders
- (c) The successful bidder shall be required to submit the final prices, quoted during the e-Auction as per the annexure after the completion of the e-Auction, duly signed and stamped as token of acceptance without any new condition other than those already agreed to before start of e-Auction.
- (d) During e-Auction, if no bid is received within the specified time, State Bank of India at its discretion may decide to revise opening price/scrap the e-Auction process/ proceed with conventional mode of tendering.
