viii) The applicant/firm should not be blacklisted or included in negative list or terminated of their services in the past by any scheduled Bank / PSU /Corporate body / Govt. body. No partner / proprietor of the applicant should have been a director / Partner / Proprietor in an entity that been blacklisted or included in negative list in the past by any scheduled Bank/PSU/Corporate body/ Govt. body. An undertaking / Certificate to this effect should be submitted in the application. If the bank finds the undertaking / Certificate provided by the applicant to be false/forged at any time, including during the term of the empanelment (If empanelled), the applicant will be immediately disqualified / terminated by the bank. - 2. For assessing the Annual Turnover of the last 3 years, contractor must submit valid documents viz certificate from registered CA, copy of Income Tax Return, copies of IT assessment order, Profit & Loss Account and Audited Balance Sheet for the last 3 year.
- 3. The intending applicants are categorically advised to submit the empanelment documents strictly in the attached formats only through online portal "<a href="https://etender.sbi"/>https://etender.sbi"/>https://etender.sbi</a> and scanned copies (in PDF format only) to be uploaded where ever it is specified. The information required should be filled/typed in each and every column and rows of the Formats.
