13.	Other conditions	(a). Bidder /Purchase to register on e-auction portal https://ebkray.in using his mobile no and email Id. KYC verification will be done, bidder to upload requisite KYC documents, which will be verified by ebkray, which in turn may take 02 working days. (b). The intending bidder should transfer the EMD amount from his Account through NEFT to his/her global EMD wallet maintained with ebkray before auction date. (c). Name of Eligible Bidders will be identified by the State Bank of India, Stressed Assets Recovery Branch, South Bengal to participate in online e-Auction on the portal https://ebkray.in . (d). The EMD of the successful bidder will be automatically transferred to the bank once the sale is confirmed by the respective Authorized Officer of the bank and the remaining amount i.e 25 % of sale price to be paid immediately i.e. on the same day or not later than next working day, as the case may be. (e). During e-Auction, if no bid is received within the specified time, State Bank of India at its discretion may decide to revise opening price / scrap the e-Auction process / proceed with conventional mode of tendering.
