- (a) Bidders shall hold a valid email ID (e-mail ID is absolutely necessary for the intending bidder as all the relevant information and allotment of ID and Password from e-bkray Portal may be conveyed through e mail.

- (c) The Sale will be conducted by the undersigned through e-auction platform provided by the e-Auction service provider at the Website https://ebkray.in/eauction-psb/home on the date mentioned above. The intending Bidders/ Purchasers are requested to register on portal https://ebkray.in/eauction-psb/home (direct link https://ebkray.in/eauction-psb/home) using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders/ Purchasers have to transfer the EMD amount using online mode in his Global EMD Wallet well in advance before the auction time.
