i	<p>Point No. 36 “The <b>Agreement will be initially for a period with 01 years</b>, with a clause that in case the Bank's not satisfied with the services extended, it will have the right to terminate the contract by giving one month notice. In such a case, the tendered security Deposit Money will be forfeited, after the lapse of initial <b>one years</b> of agreement; it can be renewed further with mutual agreement for further as per minimum wages applicable at that time.”</p> <p><b>The contract period is one year, the same is not feasible since new vans will be finance by the Bank only if the proposal is economically viable i.e minimum period of contract has to be three (03) years.</b></p>	<p>After the concurrence of the committee &amp; elaborate discussion, it seems reasonable to extend the contract period for three years instead of one year and may be extended the contract yearly basis / terminate subject to discretion of Bank's &amp; RBI guidelines.</p>

v	S.No. (33) "Bank may not be able to provide any overnight parking facility, Owner to arrange for the same at his own cost." <b>Parking facility should be clarify.</b>	Parking must be ensured at the nearby Currency Chest Branch / Police Station subject to availability of parking space if night halt required.
vi	Kindly Provide clarity on the rates for extra working hours	It will be remain same as mentioned in Tender i.e. Rs. 69/- per hr.
vii	It has been stated that for every extra hour worked on the 2 <sup>nd</sup> & 4 <sup>th</sup> Saturday, or any other holiday, an additional amount of Rs. 69 per hour will be paid. However, this rate seems applicable only for extra working hours. We request you to consider a separate amount for the full extra day of service for the van & crew. Additionally, Rs. 69/- hour does not appear to align with the central wages act for a crew of two members.	If Bank require the services of Coin Van on holidays, payment will be made to the contractor on prorata basis on the fixed monthly charges (25 days). Contractor must ensure to follow financial and non-financial obligation of labour laws to the staff deployed on van.
