The scope of work includes cleaning of lift pit, cutting, chasing, chipping RCC/bricks/plaster surface wherever necessary subject to specific approvals from Consultant / SBI and re-plastering the same to its original position, making alteration to accommodate centre opening doors at all floors, fixing brackets, rails, with necessary Bamboo/Metal scaffolding and the required infrastructure complete. - a) The price entered in <u>section I</u> against each item shall include the design, engineering, manufacturing, testing, packing, forwarding, loading / unloading, insurance, installation, testing, commissioning and handing over and shall include the due proportion of labour, preliminaries, overhead charges and profit and shall represent the value of the particular item installed, completed, tested and set to work as part of this contract.

GST shall be paid extra as per prevailing rates.
