1.	The Contractor shall arrange for the service at the Establishment. He shall adhere to the Schedule as to the time and work to be performed as described more specifically in the Schedule-I & II hereunder.
2.	The charges for rendering the services payable by the Bank to the Contractor shall be

exclusive of all taxes, the details of which are mentioned in Price bid to this agreement. However, the taxes required to be paid by the contractor shall be reimbursed by the Bank on production of receipts to that effect evidencing such payments. This Agreement is for providing the services and is not for supply of Contract labour and that the persons employed by him for providing the services more fully described in Schedule-II shall be the employees of the Contractor and not of the Bank.

#### **NATURE OF DUTIES**

#### As per the scope of the work mentioned in the tender

- The daily and periodical Operation & Maintenance of L.T. Installation of L.H.O. building, Bank House, DGMs Apartment, Senior Officer's Transit House and Staff quarters at Sashtrinagar & Bhoumanagar and the Bank's own DG set at DGM's quarters and the three nos. of Substations at the Staff quarters and DGM's quarters, shall be the sole responsibility of the Contractor. The contractor shall make all arrangement for smooth execution of work.
- The contractor shall maintain three under mentioned registers, which shall be checked/ verified by the Engineer-in-charge or Bank's official concerned before release of the bill to the contractor.

3. All the tools and tackles required for operation and maintenance services should be arranged by the contractor at his own cost and expenses. Besides these, the additional tools, if any, required during the breakdown shall also be arranged by the contractor at its own cost and expenses. All the material used for service should be certified ISI mark and or as per the brand names/others as may be specified by the Bank and materials should be of high quality and to the satisfaction of the Bank and shall be procured from reputed dealers/shops. The contractor shall arrange for their purchases on his own and shall bear all expenses in connection with such purposes.

- 4. The healthiness of overall Electrical network is sole responsibility of the contractor. The repairing/ maintenance works required, if any, should be carried out by the contractor in advance as preventive measure to get rid of any interruption to Bank officials at LHO & residents in the residential buildings/Apartments & Guest House. The contractor shall be responsible to identify the defects bring it to the notice of the Bank before its replacement. Bank shall reimburse the cost of the material replaced by the contractor. The contractor shall not claim any labour charges and overhead expenses and profit in this regards.
- 5. The contractor shall also ensure all routine and preventive maintenance services of all L.T. installation, Generator set and Transformers at the scheduled establishments and failure of any electrical equipments shall be replaced by him at his own cost, if in the opinion of the Bank, the damage has occurred due to the negligence of the contractor or its employee. The decision of the Bank, in this regards, shall be final, conclusive and binding on the contractor and the contractor shall make good the losses at his own cost.
- 6. Any damage due to mishandling of the installation, recovery shall be made from the contractor's bill and/or performance guarantee.

#### Responsibilities:-

- 7. The contractor shall ascertain the inspection fees from appropriate authority of the Govt. and collect the same from the Bank and ensure the timely deposit of the same. The contractor shall ensure timely inspection by the Electrical inspector / Asst. Electrical inspector and shall be liable to compensate the loss, if any, to the Bank for such failure.

The failure to ensure routine operation & maintenance and providing timely service to the concerned establishment or any other irregularities observed, the Contractor shall pay a sum of Rs.10,000/- per incidence, which shall be recovered from his monthly bill by the Bank.

#### 10. Liquidated Damages:

Whenever the Bank found that the work is not up to mark in any section and the same is not corrected/improved to the satisfaction of the Bank within one hour of bringing the same to the notice of the Supervisory staff of the Contractor, an amount equivalent to two days of contract amount, subject to a minimum of Rs.10,000/- (Rupee Ten thousand only) will be levied as liquidated damages per day.

He will, at the request of the authorized officer of the Bank/Establishment remove from the work any person engaged by him for the services, who may be unsuitable or incompetent or whose conduct is not trustworthy or who misbehaves and/or is not courteous, polite with the employees of the Bank or its customers or third parties.
- 15. The contractor shall strictly comply with Labor and some other statutory law in relation to the Service provided and the personnel engaged by the Contractor and he shall be solely responsible for all acts of the said personnel so enrolled and there shall and will not be any privities of Contract for any purpose and to any intent between the Bank and said personnel so engaged by the Contractor. The Bank shall not be liable nor answerable in respect of any claim or demands in respect of any matter or any account which may be raised by the said personnel so engaged by the Contractor and it shall be the sole responsibility and liability of the Contractor to answer all such claim or demand of the said personnel so engaged, under any law for the time being in force.
- 16. The Contractor shall be responsible for training, allotment of duties, hour of work and timings to the engaged personnel for the purpose. The Contractor shall alone have the right to exercise control, give directions and manage the personnel engaged, for the purposes.
- 17. The Contractor shall ensure excellent standard of Operation and maintenance of LT switchgears and also ensure that the entire equipment are kept cleaning, greasing, testing on routine basis. The maintenance of all the control panels installed in the establishment will also have to be done by the Contractor.

- 18. The Contractor shall discharge his obligation under these presents most diligently, efficiently and honestly.
- 19. The Contractor shall bear all cost and expenses and stamp duty in respect of all Agreement that may be entered into with the Bank to give effect to this arrangement.
- 20. Bank shall pay all taxes, or whatsoever as may be imposed by the State/Central Government(s) or any local body and any increase of minimum wages or statutory dues for and in connection with the rendering services.

The Contractor undertakes, accepts and admits absolute and responsibility for the service conditions, claim, damages and other compensations of the personnel enrolled by him and will be liable for and unequivocally assume responsibility for due compliance with all the requirement of all the statutory obligations, duties and liabilities (including insurance) and to pay all such claim, cost, damages, expenses, fines, penalties and compensation which may arise out of any claim, suit or prosecution for contravention thereof. The contractor shall indemnify and Keep the Bank indemnified from and against all such claims, demands, costs, charges, fines, or penalties and compensation etc. if any as aforesaid.

#### 24. Indemnity clause:-

The Contractor shall at all times indemnify and keep indemnified the Bank and its officers, servants and agents from and against all third party claims, whatsoever

including not limited to property loss and damage, personal accident, injury or death of person of any sub-vendor or the servants of agents of the vendor, any sub-vendors and/ or the owner. The Contractor shall be at his own cost and initiative at all times maintain all liabilities under workman's compensation Act/ Fatal Accident Act, Personal Injuries Act and/ or their industrial legislation from time to time in force.

- 25. The Contractor shall arrange and pay for policy under the public Liability Insurance Act,1991 and keep insured all materials which are or have been declared to be hazardous under the notifications issued or that may be issued from time to time under the above said Act or any Rule framed there under and used by the Contractor during the course of the maintenance services under these presents.
- 26. The Contractor obtain adequate Insurance Policy in respect of his workmen engaged for the service towards meeting the Liability of Compensation arising out of death, injury/disablement at work etc. and shall regularly and punctually pay each and every premium as and when the same shall become due during the currency of these presents.

- 39. Any indulgence, forbearance or waiver granted or shown or made on the part of the Bank will not prejudice its rights under the contract.
- 40. The courts in Bhubaneswar city Orissa alone shall have jurisdiction in respect of any matter touching these presents.
- 41. Nothing contained in these presents in intended nor shall be a grant, demise or assignment in law of the premises of the articles/equipments or any part thereof by the Bank to the contractor and or its personnel and they shall vacate and handover the same in good working condition and upon and termination of presents either by efflux of time or otherwise.

- "Contract" means the documents forming the tender and the acceptance thereof and the formal agreement executed between SBI and the contractor, together with the documents referred therein including these conditions, the specifications, designs, drawings and instructions issued from time to time by the Architects/SBI and all these, documents taken together shall be deemed to form one contract and shall be, complementary to one another.
- 1.1 In the contract the following expressions shall, unless the context otherwise requires, have the meaning hereby respectively assigned to them.

#### 5.0 Protection of works and property

The contractor shall continuously maintain adequate protection, of all his work from damage and shall protect the SBI's properties from injury or loss arising in connection with contract. He shall take adequate care and steps for protection of the adjacent properties. #### 6.1 Contractor to indemnify SBI

The contractor shall indemnify and keep indemnified SBI against all such damages and compensation, save and except as aforesaid and against all claims, proceedings, costs, charges and expenses whatsoever in respect thereof or in relation thereto.

#### 7.0 DURATION OF THE CONTRACT:

The contract would be initially for a period of 1 year from the date of commencement of work. It can be extended further for 2 years on the same terms and conditions subject to satisfactory performance review by the Bank annually.

#### 08.0 Local Laws, Acts, Regulations

The contractor shall strictly adhere to all prevailing labour laws inclusive of contract labour (regulation and abolition act of 1970) and other safety regulations. The contractor shall comply with the provision of all labour legislation including the latest requirements of all the Acts, laws, any other regulations that are applicable to provide CAMC service.

- i) Minimum Wages Act, 1948 (Amended)
- ii) Payment of Wages Act 1936 (Amended)
- iii) Workmen's Compensation Act 1923 (Amended)
- iv) Contract Labour Regulation and Abolition Act 1970 and Central Rules 1971(Amended)
- v) Apprentice Act 1961 (Amended)
- vi) Industrial Employment (Standing Order) Act 1946 (Amended)
- vii) Personal Injuries (Compensation Insurance) Act 1963 and any other modifications
- viii) Employees' Provident Fund and Miscellaneous Provisions Act 1952 and amendment thereof
- ix) Shop and Establishment Act
- ix) Any other Act or enactment relating thereto and rules framed there under from time to time.

#### 9.0 Force Majeure:

9.1 Neither contractor nor SBI shall be considered in default in performance of their obligations if such performance is prevented or delayed by events such as war, hostilities revolution, riots, civil commotion, strikes, lockout, conflagrations, epidemics, accidents, fire, storms, floods, droughts, earthquakes or ordinances or any act of god or for any other

cause beyond the reasonable control of the party affected or prevented or delayed. However a notice is required to be given within 30 days from the happening of the event with complete details, to the other party to the contract, if it is not possible to serve a notice, within the shortest possible period without delay.

- 9.2 As soon as the cause of force majeure has been removed the party whose ability to perform its obligations has been affected, shall notify the other of such cessation and the actual delay incurred in such affected activity adducing necessary evidence in support thereof.
- 9.3 From the date of occurrence of a case of force majeure obligations of the party affected shall be suspended during the continuance of any inability so caused. With the cause itself and inability resulting there from having been removed, the agreed time of completion of the respective obligations under this agreement shall stand extended by a period equal to the period of delay occasioned by such events.
- 9.4 Should one or both parties be prevented from fulfilling the contractual obligations by a state of force majeure lasting to a period of 6 months or more the two parties shall mutually decide regarding the future execution of this agreement.

#### **SCOPE OF THE WORKS TERMS AND CONDITIONS:**

#### **LOCAL HEAD OFFICE, BHUBANESWAR- WORKING HOURS**

- 1) One Electrician capable to handle the aforesaid job must be available in two shifts i.e; 6AM to 2PM & 2PM to 10PM every working day.
- 2) One helper/ unskilled person should be invariably engaged with each wireman/ electrician in each shift. During duty hours, all these members should attend the faults at the concerned locations on priority.
- 3) One Lift operator in each shift capable to handle the operation of all the lifts at LHO must be available in two shifts i.e; 6AM to 2PM & 2PM to 10PM every working day.
- 4) The duty hours of the workman/Technician etc. should not exceed 8 Hours per shift per day. The company/firm has to comply the labour Act. of maximum 26 shift duty/person/month limit.
- 5) BANK HOUSE, DGM'S QUARTERS, NAGESWAR TANGI SENIOR OFFICER'S GUEST HOUSE, STAFF QUARTERS & OFFICERS GUEST HOUSE AT SASTRINAGAR & BHOUMANAGAR- WORKING HOURS
- 1) One Electrician/ wireman each for Bank house & DGM's Quarters capable to handle the aforesaid job must be available from 6AM to 10PM.

- 2) Two helpers/ unskilled persons should be invariably engaged with one wireman/ electrician for Nageswar Tangi Senior Officer's Guest House, Staff quarters & Officer's guest house at Sastrinagar & Bhoumanagar from 6AM to 10PM everyday. During duty hours, all these members should attend the faults at the concerned locations on priority.
- 3) The duty hours of the workman/Technician etc. should not exceed 8 Hours per shift per day. The company/firm has to comply the labour Act. of maximum 26 shift duty/person/month limit

#### **NATURE OF DUTIES:-**

- 1) The contractor will be responsible to arrange for operation and maintenance of all the Electrical power panels & the total distribution network, switches & circuits including the water pumps and HT substations/ RMUs for residential quarters, office etc. on routine basis and also in emergency as and when required. The operation of five nos. of lifts at LHO, BBSR and one lift at DGM's Quarters and their power supply etc are the responsibility of the contractor.
- 2) However the healthiness of overall Electrical network is sole responsibility of the contractor. The repairing maintenance/ modification works required (if any) should be carried out by contractor in advance as preventive measure to get rid of any interruption to Bank/ residents in the quarters. The works shall be executed to the entire satisfaction of the Engineer-in-charge/ Bank official concerned. The contractor shall be responsible to identify the defects bring it to the notice of the Bank before its replacement. Bank shall reimburse the cost of the material replaced by the contractor. The contractor shall not claim any labour charges and overhead expenses and profit in this regards.
- 3) Any damage due to mishandling of the installation, recovery shall be made from the contractor's bill/ performance guarantee.
- 4) The contractor should maintain three registers as noted below:

- 5) The contract can be terminated by the contractor with one month notice, after necessary approval from the Bank.
- 6) The contractor must intimate the address of his office and residence along with land and mobile numbers.
- 7) The contractor will have to make timely payment (i.e; within 5days of the due date) to the workers engaged for the contract, failing which the authority has sole rights to withhold the bill of the contractor until finalization of irregularity observed.
- 8) For accident/ miss-happening at site with the workers engaged, the contractor will be liable to Bank.
- 9) In case of absence of any hikilled/skilled/ semi-skilled/ un-skilled worker in any shift/ day, recovery as per prevailing wages rate per person will be made available from the contractor's bill.
- 10) In case the workers engaged are not delivering the satisfactory performance, the contractor will have to replace him/ them immediately; otherwise such person will not be allowed to enter in our premises and will be treated as absent and recovery shall be made as per clause no (09) above.
- 11) **DG Set:** Complete preventive maintenance of DG sets which includes regular general checkup such as checking of coolant level, oil level, fuel system starting system etc to be carried out. Servicing to be carried out through OEM or authorized dealer of supplier.
- 12) **DP structure**: Maintenance of 11KV 4 pole structure, AB switch, HG Fuse, greasing of moving parts 33KV cable termination and, Checking of insulators against crack,

#### **PAYMENT TERMS:-**

- 1) Bank will pay the monthly contract amount every month on satisfactory completion of work, after deduction of taxes & penalty/ dues (if any) as required. However the wages shall be paid to the Hi-skilled/skilled/ semiskilled/ un-skilled workers as per the schedule of rates fixed by Govt. of India time to time.
- 2) The EPF, ESI & GST shall be paid as per Govt. of India. Any revision in this matter by Govt. Of India will be introduced/ revised time to time with necessary approval from Bank. The vendor should register with EPF & ESIC

#### PENALTY CLAUSE:-

 The contractor needs to operate and maintain all the equipments & distribution network in healthy condition so that the officials concerned/ occupants in the residential buildings are not affected. Any irregularities observed, in providing timely service to the concerned office/ residential quarter will cost Rs.10,000/- per incidence to the contractor, which will be recovered from its monthly bill by the Bank.

#### **RISK CLAUSE:-**

1) SBI reserves the right to discontinue the service at any time, if the services are found unsatisfactory by giving show-cause to be replied within a week and also has the right to award the contract to any other agency at the risk and cost of current agency and excess expenditure incurred on account of this can be recovered from security deposit or pending bills or by raising a separate claim.

#### LIQUIDATED DAMAGE CLAUSES:-

- 1) An amount equivalent to two days of contract amount, subject to a minimum of Rs.10,000/- (Rupees Ten Thousand only) will be levied as liquidated damages per day. Whenever and wherever it is found that the work is not up to mark in any section, it will be brought to notice of the supervisory staff of the firm by the Bank and if no action is taken within one hour liquidated damages clause will be invoked.
- 2) Any misconduct/ misbehaviour on the part of the manpower deployed by the agency will not be tolerated and such person will have to be replaced immediately.

#### **STATUTORY OBLIGATIONS:**

- 1) The tenderer shall fully comply with all the applicable laws, rules and regulations relating to Contract Labour (Regulation and Abolition) Act 1970 and Contract Labour (R&A) Central Rules 1971, Provident Funds Act including the payment of P.F. contribution, Payment of Bonus Act, Minimum Wages Act, Workmen's Compensation Act, ESI Act, Migrant Labour Act and / or such other Act or laws or regulations passed by the Central, State, Municipal and Local Government agency or authority including TDS as per I.T. Act, applicable from time to time.
  - 2) The tenderer shall be responsible to register himself and obtain a valid license under the Contract Labour (Regulation and Abolition) Act, 1970 and rules there under and the vendor must comply with and carry out all the provisions and obligations under the said Act and Rules there under, including renewal of license and furnish all information to the Bank as may be required by Act/Rules and the vendor shall indemnify the Bank against the penalties/claims or for any default on his part.
  - 3) The tenderer shall be responsible for proper maintenance of all Registers, Records and counts so far as these relate to the compliance of any statutory provision/obligations. The vendor shall be responsible for maintaining record pertaining to payment of wages Act and also for depositing the P.F. contributions, if required, with authorities concerned.
  - 4) The tenderer shall make regular and full payment of labour charges, salaries and other payments as per labour laws especially under Minimum Wages Act and

- Payment of Wages Act to his workmen deputed for the work and furnish necessary information as and when asked.
- 5) In case of labour unrest/disputes arising out of non-implementation of any law, the responsibility shall solely lie with the Vendor and he shall remove / resolve the same satisfactorily at his cost and risk. The Vendor will abide by rules, regulations, bylaws and statutes etc. for executing for his job.
- 6) The tenderer shall at all times indemnify and keep indemnified the Bank and its Officers, servants and agents from and against all third party claims, whatsoever including not limited to property loss and damage, personal accident, injury or death of person of any sub-vendor or the servants of agents of the Vendor, any sub-vendor(s) and/ or the owner. The vendor shall be at his own cost and initiative at all times maintain all liabilities under workman's Compensation Act/Fatal Accident Act, Personal Injuries, Insurance Act and/or their industrial legislation from time to time in force
- Price variation for Labour component: It will be given, based on the actual rise/fall in the minimum wages structure, as per applicable notifications issued by the Central Govt., whenever applicable along with the statutory compliance. After occurrence of any such incidence, the Contractor will bring to the notice of the Bank through letter, clearly showing the difference in minimum wages between the current minimum wage and during the time of bidding and shall submit the revised bill., However, the expenses towards service, maintenance, profit etc. quoted in schedule -B at the time of bidding shall be remain unchange during the contract period. However, GST shall be mentioned separately and will be paid by the SBI at actual as applicable. The SBI will scrutinize the calculations and make all endeavour to pay the bill if found in order.

#### **TERMINATION:**

- 1) The Bank reserves the right to terminate the contract any time during the pendency of the contract on failure by the vendor to adhere to the conditions hereinabove indicated or agreed in the contract. Such termination will be communicated in writing to the vendor and any work affected beyond date of termination of the contract shall not be measured and paid for.
- 2) In case the Bank decides to terminate the contract, it shall do so by giving seven days notice only.
- 3) If the performance of the successful tenderer is found to be unsatisfactory, the Bank reserves the right to cancel in part or whole the contract and get the work executed through alternative means at the entire risk and cost of the vendor with whom the work order was first placed. In such cases, the vendor should make good all losses that the Bank may incur due to this. The Bank may proceed with legal actions if necessary.

The Assistant General Manager (P&E), LHO, BHUBANESWAR reserves the right to reject any or all tenders in whole or in part without assigning any reasons therefore. The decision of Assistant General Manager (P&E), LHO, BHUBANESWAR shall be final and binding on the contractor/ agency in respect of any clause not covered under this contract.

#### **OTHER TERMS & CONDITIONS**

- 1) The daily and periodical operation and maintenance services shall be sole responsibility of the contractor. The cost of repair and servicing of all the articles/ equipments shall be exclusively borne by the contractor only as per clause no (02) under "Nature of Duties.". The details of which shall be entered in the "PREVENTIVE MAINTENANCE REGISTER" & "ROUTINE/ EMERGENCY MAINTENANCE REGISTER" and to be checked by the Engineer-in-charge or Bank's official concerned before release of monthly bill.
- 2) All electrical tools and tackles like Multi meter, Megger, ladder etc required for Operation and maintenance should be arranged and stationed at site permanently by the contractor at its own cost and expenses. All the materials used for services should be certified ISI mark and as per Make specified by the Bank and materials should be of high quality and to the satisfaction of the Bank and shall be procured from reputed dealers/ shops. The contractor shall arrange for their purchases on his own and shall bear all expenses in connection with such purchase.
- 3) The contractor shall identify the defects well in advance and bring to the notice of the Bank before its replacement. Bank shall reimburse the cost of material replaced by the contractor, strictly according to clause no (02) under "Nature of Duties.". The contractor shall not claim any labour charges and overhead expenses and profit thereon.
- 4) However considering the volume of services/ work involved in overhauling of set and Transformer including sub-station area etc. the Bank may consider the payment of labour charges and overhead expenses, if any, claimed by the contractor as deemed fit.
- 5) The contractor shall also ensure all the routine and preventive maintenance services of all electrical equipments installed in the substation at the establishment and failure of any electrical equipments shall be replaced by him at his own cost, if in the opinion of Bank, the damage has occurred due to negligence of the contractor. The decision of the Bank in this regard, shall be final, conclusive and binding on the contractor and the contractor shall make good all the losses at his own cost.
- 6) The contractor shall ascertain the inspection fees from appropriate authority of the Govt. and collect the same from the Bank and ensure timely deposit of the same. The contractor shall also ensure timely inspection by the Electrical Inspector, Govt. of Odisha/ Gol and failure to undertake such inspection as required, the contractor shall be held responsible for compliance of the observations of the Electrical Inspector and shall be liable to compensate the loss, if any, to the Bank for such failure.
- 7) The contractor shall be responsible and liable for safety of the personnel engaged by him and provide them all safety instruments including shoes, apron, gloves, discharge rod and any other equipment required for the purpose.
- 8) The contractor shall strictly comply with all labour and such statutory laws in relation to the services to be provided and the personnel engaged by the contractor and he shall be solely responsible for all acts of the said personnel so engaged by the contractor. The Bank shall neither be liable nor be answerable in respect of any claims or demands in respect of any matter or any account which may be raised by the said personnel so engaged by the contractor and it shall be the sole responsibility and liability of the contractor to answer all such claims or demands of the said personnel so engaged, under any law for the time being in force.

AGREEMENT ON STAMP PAPER: The selected tenderer / vendor will have to enter agreement on non-judicial stamp paper of requisite value, within 7 days of acceptance tender, and all the costs with respect to the same shall be borne by the / vendor.
