- a. Preference will be given to those who have history of timely completion of works of similar nature, taken up by them during the last 7 years.
- **b.** Those who are earlier empaneled by the Mumbai Metro Circle of the Bank need to apply afresh
- c. The Bank's officials or their authorized representatives will visit your manufacturing unit(s)/factory to inspect about the facilities available for manufacturing and testing of the equipment before finalizing for empanelment. The decision of the committee as regards to suitability of the vendor is final.
- **d.** The applicant shall agree and authorize the Bank to obtain the confidential report from the clients to verify the work executed by them.
- e. This empanelment shall be valid for the entire Mumbai Metro Circle of SBI for a period of **three years** from the date of empanelment.
