		(b) The Intending bidder should transfer his EMD amount by means of challan generated on h bidder account maintained with MSTC Ltd https://www.mstcecommerce.com/auctionhome/ibapi/index.jsp. by means of NEFT/ RTG transfer from his bank account.
		(c) The Intending bidder should take care that the EMD is transferred at least one day before the date of auction and confirm that his wallet maintained with M/s.MSTC Ltd is reflecting the EM amount without which the system will not allow the bidder to participate in the e-auction.
