- (i) The applicants
 - a. Shall fulfill the eligibility criteria of the work individually.
 - b. Shall submit applications dealing with work for supply, installation & maintenance of fire extinguishers and certified copies of supporting documents including BIS (IS:)certificates of all type fire extinguishers.

(ii) The contractors/vendors empaneled by SBI in the past need to apply afresh, else they will not be considered for empanelment.

(xi) The applicant/firm should not be blacklisted or included in negative list or terminated of their services in the past by any scheduled Bank / PSU /Corporate body / Govt. body. No partner / proprietor of the applicant should have been a director / Partner / Proprietor in an entity that been blacklisted or included in negative list in the past by any scheduled Bank/PSU/Corporate body/ Govt. body. An undertaking / Certificate to this effect should be submitted in the application.
