The registration process takes minimum of two working days. (Registration process is detailed on the above (b) The Intending bidder should transfer his EMD amount by means of challan generated on his bidder account maintained with ebkray.in at https://ebkray.in by means of NEFT/ RTGS transfer from his bank account. (c) The Intending bidder should take care that the EMD is transferred at least one day before the date of auction and confirm that his wallet maintained with ebkray.in is reflecting the EMD amount without which the system will not allow the bidder to participate in the e-auction.
